Introduction



estiges of the red-light district are found in a steep-walled almost claustrophobic section of Upper Brewery Gulch. The broken foundations of the ill-famed houses survive as low yellowish-rock walls. These are mixed with short staircases of grey, crumbling concrete. It is difficult to imagine that this 400 feet of gulch was home to one of the most turbulent locations of the southwest. Under the light of lanterns, fiery, temperamental, yet scantily-clad ladies tantalized customers from wide porches. The strong notes played from the ivory keys of pianos were accompanied by sweet feminine voices and those deeper sounds of intoxicated miners. Hidden away were smoke filled rooms and intricate oriental pipes, where others found solace in a poppy induced dreamy state. Tempers flared, blood was drawn and life was taken among these ruins. Thieves and brutally mean men called this area home. At the same time these now vacant lots once provided a source for secret desires, passion, infatuation and more rarely true love. Dark rumors slowly developed accusing red-light house owners of participating in the “*White Slave Trade*” and importing sweet, innocent young girls into the wickedness of the red-light life. Then suddenly, with World War I, it was gone. Time eroded, rapidly and harshly at the district’s history. Only faint whispers remain of a district whose vitality drove the carnal desires of men wild and filled the purses of alluring goddesses of sex with gold.

The Restricted District



It is unknown when the first dusty desert dove made her way into the lonely mountains of Bisbee. Concealed within her femininity was the undaunted, steel, courage that matched any prospector, Indian scout or soldier. She would have discovered a camp built of tents and simple wooden and stone houses nestled at the foot of a prominent, red, iron oxide stained mountain. The simple homes extended up into the narrow grey limestone canyons filled with scrub oak. Acrid smoke from the crude smelter choked the air. Single, youthful, men often of a rather coarse character populated the infant community. The majority worked as miners for the Copper Queen Mining Company or the Holbrook & Cave Mining Company.

For the lady of the bawdy life, Bisbee placed no restrictions on her, she could work or live where she desired. Even saloons initially catered to these adventurous women as well as men. As the mines found increasing amounts of copper ore, it became apparent that Bisbee was not going to be a boom town, but rather a permanent community. Changes began. Other daring women arrived and families immigrated to the obscure little camp. Civilization began. The residents decided that that both the saloons and houses of ill-fame needed to be contained separated from the ideally wholesome homes of families. Thus, began the development of a respectable community. On May 7, 1892, the far end of Brewery Gulch was designated as the red-light district. Locally, the red-light district was often referred to as the "Reservation".

How the earliest ill-famed ladies behaved when they were allowed to work freely among the entire city is unknown, but if the later history gives a clue, creating a restricted district was an excellent decision. These girls and their customers could be mighty wild. In the



new red-light district, the girls ideally, would be let to their own vices of uninhibited dancing, gambling, a river of overpriced liquor and more discreetly sex. Those who chose could limit interaction with the decadent ladies by their distance from the district. Details about the early district are few, but as the late 1890's approached, local newspapers had developed. The news of troubles in the red-light district began to be regularly recorded. Generally, they were the same issues that prevailed in all the ill-famed districts in the West, fighting, robbery and drunkenness.

A hefty, monthly license was charged for ill-famed houses in 1902 of \$30.00. In 1906, the fees became more specific.

Houses with four or less girls working at them paid \$30.00 a month.

Houses with five girls employed were charged \$35.00 per month

Houses with six ladies were charged \$40.00 per month.

Houses with seven girls were charged \$45.00 per month

Houses employing eight girls paid \$50.00 per month

Any house were more than eight girls were employed paid \$60.00 per month

Over two dozen brothels that operated in Bisbee and surrounding communities.

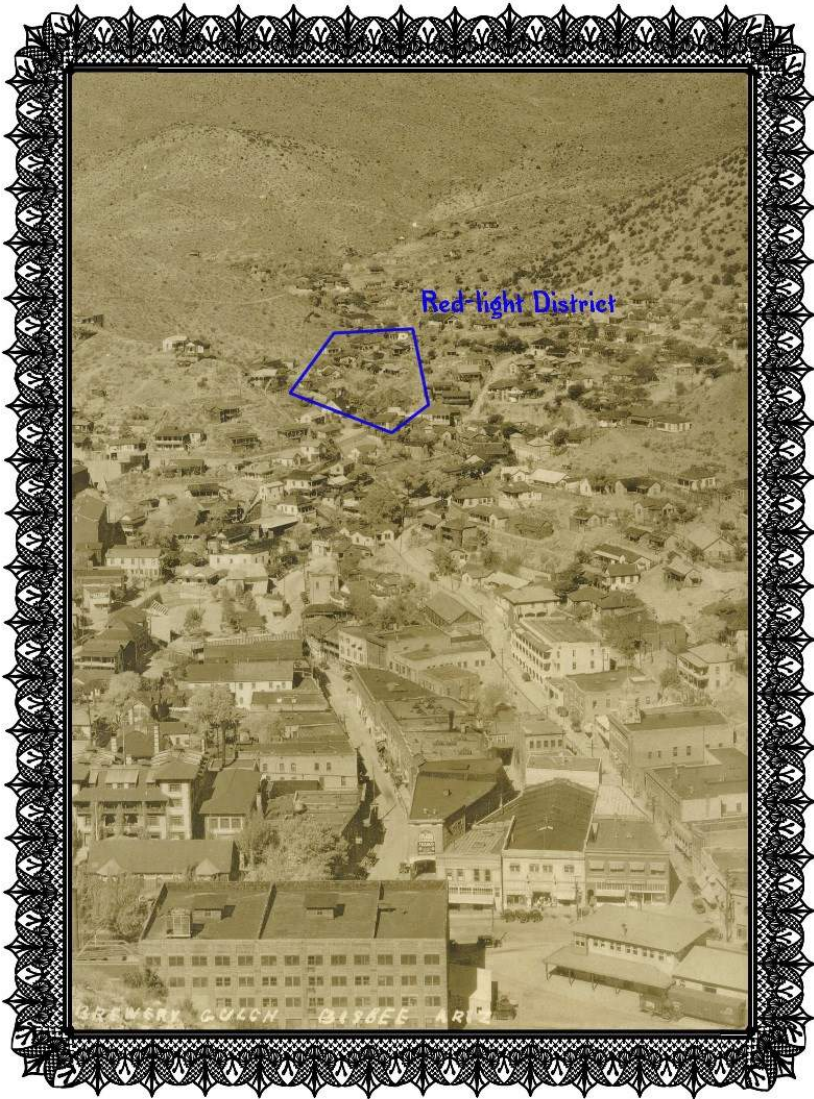

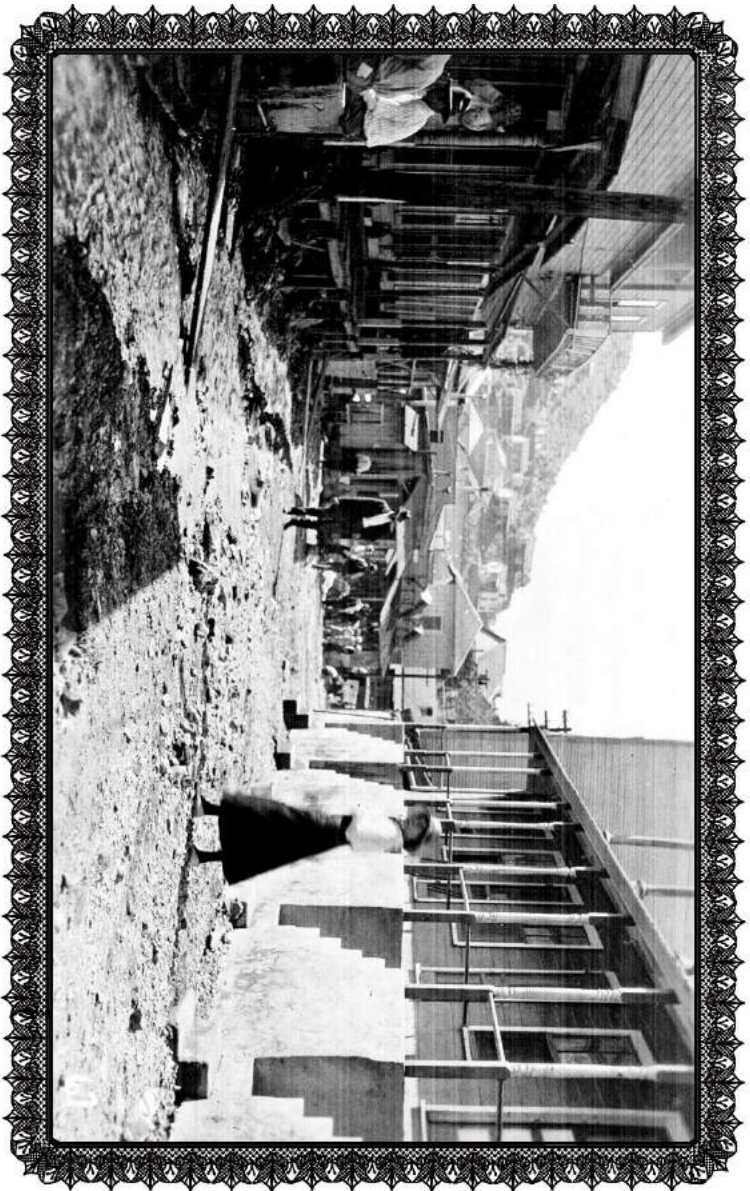

In 1902, laws were also passed that prohibited women from entering saloons outside of the red-light district. This was to prevent the girls from procuring customers outside the ill-famed district and prevent young girls from being influenced and joining the ill-famed lifestyle. At the same time children were forbidden from being in an ill-famed house between 9:00 pm and 6:00 am without a legitimate excuse. In modern times it may be confusing to think children were allowed at all in the red-light district, until one remembers that underage boys performed essential work in the community by delivering groceries, purchased dry goods, newspapers and messages. This system did not work perfectly. In 1905, William Phillips a seventeen-year-old was stabbed to death in a fight at the Little Casino, a red-light house. The fight started over one of the district's girls. One young newspaper boy discovered an attractive recent addition to the district and arranged for a short time to trade the newspaper for her services.

During 1905, laws were drawn up creating two saloon districts One on Main Street, south of Castle Rock and another in Brewery Gulch from the mouth until the city limits. The saloons were required to be operated within 200 ft. of the streets. Saloons were still allowed inside the red-light district.

Ill-famed houses were not the only buildings in the red-light district. There were regular homes located above the gulch bottom and away from the ill-famed houses and further up the gulch in an area known as Zacatecas Canyon. The Queen Laundry was an important business legally located in the gulch beyond the houses of the red-light district. At times the residents living in the district would become annoyed with their loud neighbors as regular citizens still lived there until its closure and beyond.

Many a customer of the district found their wallet suffering from a lack of currency after a visit. It can be argued that in many cases the men were too drunk to remember spending their money. In other cases the ladies provided a convenient explanation or scapegoat to explain missing cash. Of course, some of the men were actually robbed. Regardless, being robbed in the districts became a symbol of a young man's foolishness.

Brawls were common, often these were simply just two men settling their problems with fists. Yet, others chose the deadliness of a thin steel blade or the cocking of a cold steel pistol. On April 27, 1907, red-light madam, Lee Watson was confronted by one of her girls, Rosie Highwarton. Rosie's consort Harry Highwarton grabbed and held Lee while Rosie's proceeded to stab her with a knife. Watson was seriously, but not fatally injured. The Highwartons were held for a Grand Jury. There was indication that this attack may have been revenge for an undescribed incident in Montana in 1902. Because of such incidents, a special duty night police officers had to be assigned to restrain the ladies and men of the district.

At times, the occupants of different houses would battle each other leaving the ground covered in shattered glass. The justice court would be filled with red-light girls and their consorts. These girls entered the court dressed in the peaks of fashion and wearing a few battle wounds. Such an event was recorded in 1912.

"The Majestic, a resort in the reservation, was scene of a three hour battle early yesterday morning, in which bottles glasses and fist were used to detriment of heads and furniture. The Fight, which raged with varying intensity, followed a post-pay day revelry. It began about 4 o'clock and the din of battle did not die until the limpid light of seven o'clock in the morning lit up the ghastly, glass-strewn battle ground.

With the exception of black eyes, red noses, green snakes and brown tastes, no damage was done to the participants, including Amazons of the Underworld, silk-socked hangers-on and invaders of the reservation. The fight was all local as the battle of Agua Prieta or the siege of Naco and reports of the fight did not reach the police until after the empty bottle ammunition gave out and the fighting ceased.

A piano that had been rented was ruined by a flood of broken glass and wine and the owner compelled the renter to purchase outright, it being fit for nothing but Turkey Trot rag." (March 13, 1912).

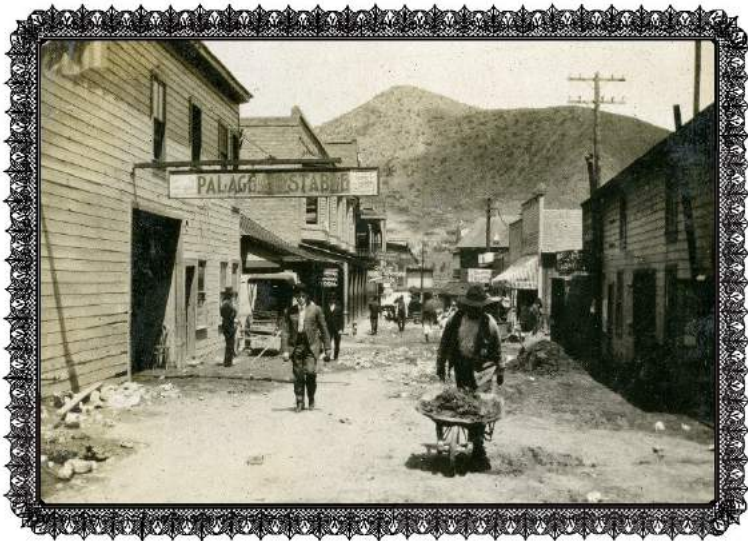
A more unique problem was the girls renting horses. The



ladies were notorious for wildly racing them along Naco Road and sometimes even into the ill-famed district. The Bisbee Daily Review reported these details of the ride that two girls that had rented horses.

At 5; 30 am July 10, 1906, *“thinking a troop of cavalry must be going through town, the curious raised the windows and peering out beheld two daring female riders urging two foam-flecked steeds in a neck to neck race”* The two riders of the red-light were arrested by Officer Jay Wilmoth.

Ada Beaumont was one of these daring ladies until, she was thrown from her horse and fractured both her upper and lower jaw. The injury was predicted to be fatal and the other girls in the district packed her belongings, removing anything that indicated her illicit past and sent her home to Kentucky. It is unknown whether it was truly a fatal injury.

A few months earlier, May Derowe a girl from No. 41 was thrown from a horse. The doctors felt that her massive hairdo cushioned the blow and possibly saved her life. It was popular at the time, to add extra hairpieces even to luxuriant natural hair.

Ed Fletcher saw a girl who had rented one of his horses to go to the circus. She was wildly intoxicated and had run the horse into a barbed wire fence. In trying to stop the woman and rescue the injured horse, Frank Haywood a man riding with the scarlet lady, struck him on the neck, leaving Fletcher temporarily unable to speak.

In 1903, mining operations in Bisbee exploded in number and moved south east from Bisbee. As a result the suburb of Lowell was



built. By 1904, the ladies of the red-light began to move into Lowell. At this time, Lowell was consider its own community separate from Bisbee with its own Justice Court and police officers. The vivacious women found themselves unwelcome and were met with resistance, but Con & Lillian Shea successfully moved their house from Brewery Gulch to Upper Lowell.

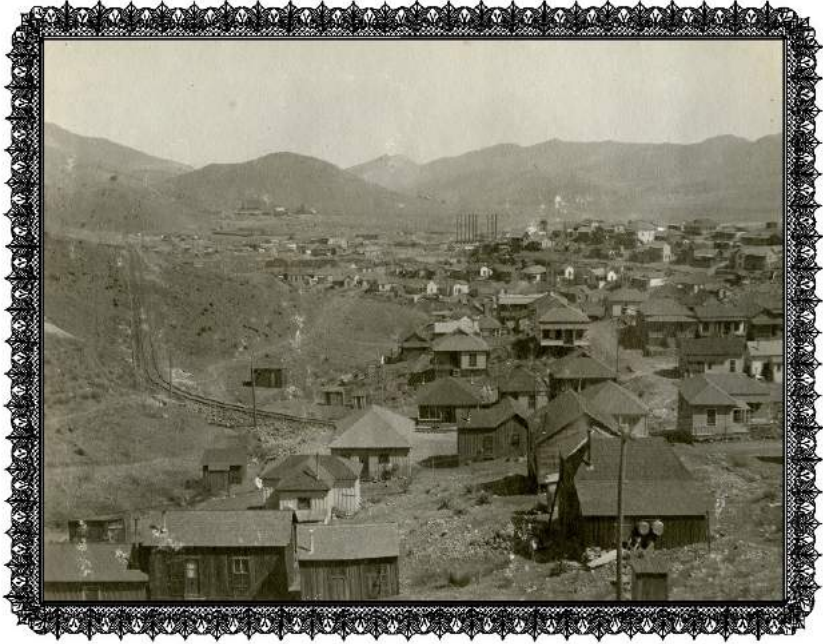

Also, the Beer Garden in Johnson Addition at times was frequented by ill-famed ladies. Red-light houses in Lowell were quieter than on Brewery Gulch. One of the few occasions that trouble resulted was when Nellie Bond an ill-famed girl walked through Lowell completely nude and totally intoxicated. On July 16, 1910, at around between 2 and 3 am four woman broke out into a brawl that was describe as *“a racket as one might suppose would happen were a good sized cattery to be suddenly dumped into a well populated dog kennel.”* Four woman were arrested and were referred as *May Coe, Claire Doe, Myrtle Hoe* and *Pearl Roe*. Their actual names are unknown and they were likely girls of the red-light. The exact locations of the houses is unclear, but they were in upper Lowell and Johnson Addition. One short lived ill-famed house operated further



south in Tin Town during 1910. Little is known about this house, but the madam was arrested on immigration violations.

Thoughtful planning of the designers of the Warren community prevented any of the land sold by the Warren Development Company to “*at any time be used for the sale of intoxicating liquors in any form, nor for gambling places or houses of ill-fame: also the must not be used for slaughter-houses, hog-pens or any form of nuisance or approach thereto.*” Warren was developed to be “*The City Beautiful*” a planned community where both company officials and miners lived in and away from the socially and physically polluted canyons of Bisbee. No houses of ill-fame are known to have existed in this part of town. A young lady, Carmen Mora was arrested for running completely nude through Warren in 1907. The woman had become intoxicated with Camilo Cortez and Daniel Tapia. Carmen decided she wanted to sprint naked through the areas where houses



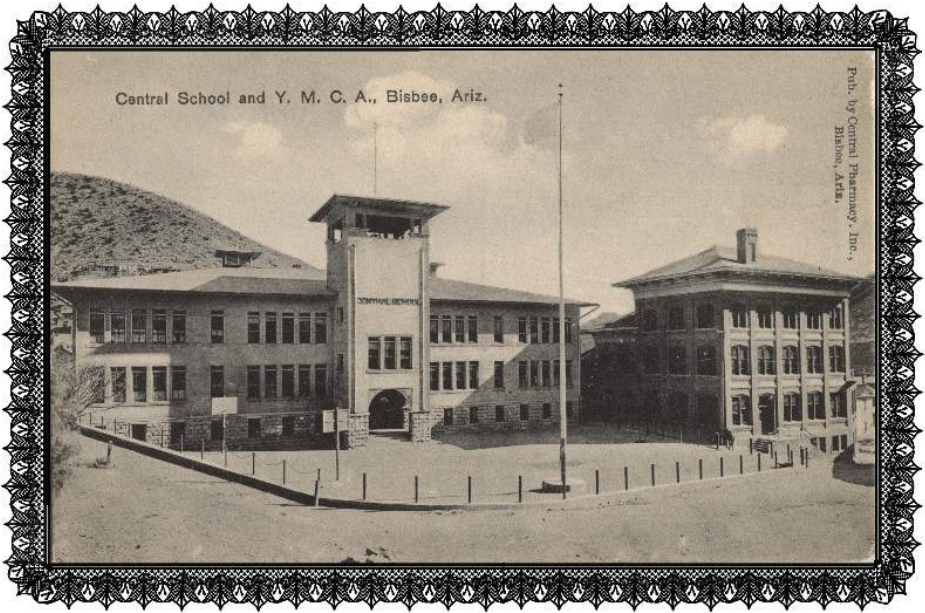
were to be built. Drunkenly, the two men ran after her. Construction workers and residents of Warren were treated to this entertaining if not shocking sight. All, three were arrested. Carmen received 60 days in jail and the two men were given small fines. Although, Carmen made less than ideal choices, there is no conclusive evidence she was an ill-famed lady.

Central School was problematic for the ill-famed district. A small adobe school house had been replaced by a massive multi-storied building in 1905. The structure was located 1,200 ft. from the red-light district's southern boundary. This was the minimum legal distance that the red-light district could be located near a school. In 1906, the minimum legal distance was upped to 1,300 ft. This forced the closure of the ill-famed houses on the southern end of the red-light district.

The girls had difficulty respecting this law and tried to operate their houses even on Main Street. Arrests were made at the Opera Club Lodging House, the Norton House and in the apartments above the Butte Saloon. On the Broadway pathway and near the Calumet and Arizona Hospital, ill-famed ladies also opened houses. At the Butte Saloon, in 1905 the women were accused of trying to attract customers on the street below while scantily clad. Mrs. Fox one of the accused had been seen frequenting wine rooms to solicit customers. She had also been discovered on the streets trying to improve business. Mrs. Fox was arrested and found guilty. Justice McDonald fined her \$75.00 and released her after her attorney appealed the conviction. The young lady then proceeded to harass the jurors who found her guilty in the town. The Norton House was particularly problematic. Constables knew the building was being used for immoral purposes. They had investigated, but each time the officers were unable to charge a woman. Finally, in April of 1906, the Norton House was raided and four women were arrested for operating an ill-



famed house within 1,300 ft. of Central School. This last raid seemed to quell the interest of ill-famed girls using this building as a place of business.

Painted ladies women were low on society's social scale, but they were not at the bottom. The lowest level was reserved for a despised group that lived in the red-light district as vagrants. Hobos and tramps also passed through the district and often were not overly popular, and were being charged with vagrancy or "*vagged*" to get them to leave town. The true despicable vagrants in the minds of the citizens were men who had no visible income and lived off the earnings of an ill-famed lady. Police constables regularly searched for and arrested individuals in the district on vagrancy charges. Typically, they skipped town before their trial at the justice court, but there was a constant stream of new vagrants to replace them. To help



eliminate them in 1914, a law was passed that prohibited any man from working or living at an ill-famed house. This included piano players. The law further stated that men in general were not allowed to be seen in public with the ladies. This was to prevent “chaste” women and children from seeing well-dressed men with elegant ill-famed ladies riding together thru town. Bisbee wanted to prevent any encouragement for a young woman to join the life of the red-light.

The wild events of misbehavior built up and over time, it became essential to place further restrictions on the district. On April 1, 1910, Bisbee City Ordinance 153 went into effect and closed all dance halls and saloons in the red-light district. April Fool’s Day 1910:

“Last night marked the final appearance of Bisbee’s tenderloin as a blazing myriad of mahogany counters, foaming liquor, polished glasses and “Smiling young man dressed in white.” Foolish young swains inflamed by liquor can no longer visit that district and spend what money they have in a wild debauch with the female denizens of the region, paying exorbitant prices for what they drunkenly consume”.

“Then again, last night the bawdy- house orchestras sounded their farewell notes, the women hopped about in a farewell two-step and the dance hall doors were closed to open no more. The polished floors will either be left deserted or turned into parlor apartments.”

For the girls, this was financially devastating. They depended on dancing and commissions on selling overpriced drinks as an essential part of their income. After this legislation, the district declined and a newspaper claimed that half the girls left for other red-light districts. Particularly, the girls headed for the district at El Paso. The closing of the red-light district’s saloons was less effective. Liquor was brought into the district by the customers or “given away” by the house. Also in 1910, the girls were ordered to stop advertising in the district by standing outside their rooms scantily dressed, enticing potential customers



The robbing and drunkenness still continued as before, but the Bisbee Daily Review expressed concern that the new restrictions had resulted in a surge of violence. This increase appears to be in inter-house conflicts and resulted from difficulty to earn an adequate income and heightened competition. They were no longer selling companionship by drinking and dancing. The market was largely reduced to sex.

Bisbee was a tolerant community and did even not make a fuss over the X-ray gown that actress Claire Simpson wore through town. Made of diaphanous cloth, the dress exposed more than it concealed. She was later arrested in Tucson for wearing the same outfit. Yet, this toleration had limits.

Bull fighting at nearby Naco, Sonora was poorly received by Bisbee residents. This was largely blamed on the practice of having the bulls gore horses to death before the fight to show their ferocity. This unnecessary blood thirsty feature was highly disapproved of and likely lead to the failure of this form of entertainment. Also, the artist talents of Adolphe Cedro failed to meet public approval in Bisbee. He was known to use the ladies of the underworld for his inspiration and painted them only in the "*habiliments of nature.*" An oil painting that he created under commission of Ray Ovens was discovered by the constables during a raid and Adolphe was arrested for painting lewd pictures. Interestingly, the painting seized was painted on the box that once contained a burial robe. During his trial, the painting faced away from the audience and was discreetly shown to the jury members. Although, the arresting officers artist recognized the talent of his technique and use of color, his work of art was taken to Tombstone to be destroyed. The artist was sentence to 90 days in jail without his brushes and paints. Ovens paid three dollars for the painting, but later received a \$50.00 fine for distributing a lewd painting.





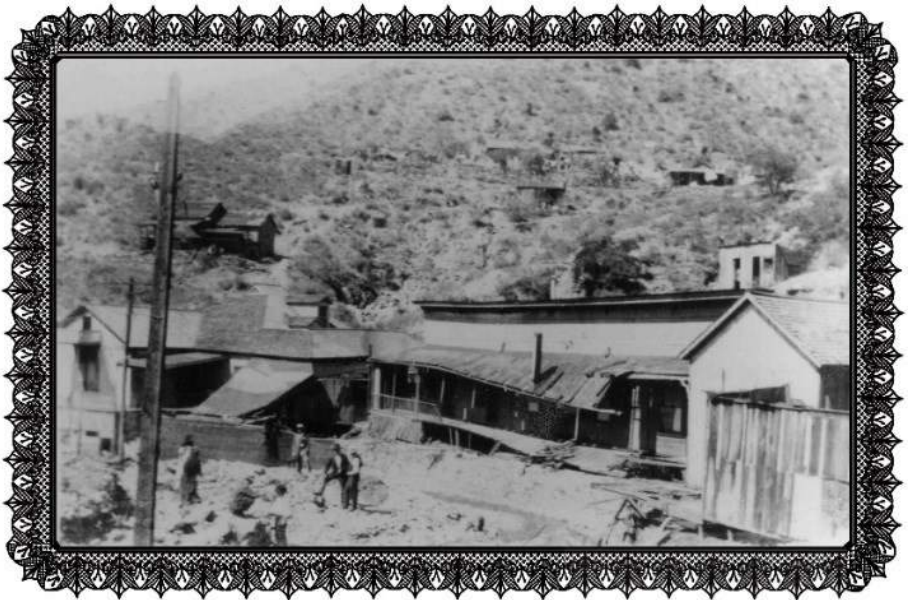

Floods and fires had plagued the community since the early days, but the red-light district was largely spared. There were a few small fires, but these were quickly extinguished. On July 22, 1910, in the height of the “*monsoon season*”, a torrent came down the upper reaches of Zacatecas Canyon tearing apart buildings and damaging others. The Bisbee Daily Review stated,

“The denizens of this section who were flooded out are housed with their more fortunate neighbors on the high ground while lights left burning reveal the scene of wreck, ruin and disarray of gaudy



furniture. At one point where a house was more badly damaged than usual a woman sat on the opposite side of the street in the room of a friend who had taken her in. In her hand she held a Colt's 45, and called a shrill warning to any who ventured too near her ruined house."

Another flood in 1917, left the rooms of the girl's knee deep in mud and one ill-famed lady who was sick in bed was rescued only moments before her house was washed away. Many of the district's residents were left with only inadequate clothing. The majority of their clothes being ruined. Early estimates predicted \$10,000 of damage to Upper Brewery Gulch not including individual losses.

In 1910, revolution broke out in Mexico. Bisbee residents had strong ties to Mexican communities particularly to Cananea, Sonora. Both communities contained large numbers of former residents of each city. Regiments of soldiers were quickly stationed along



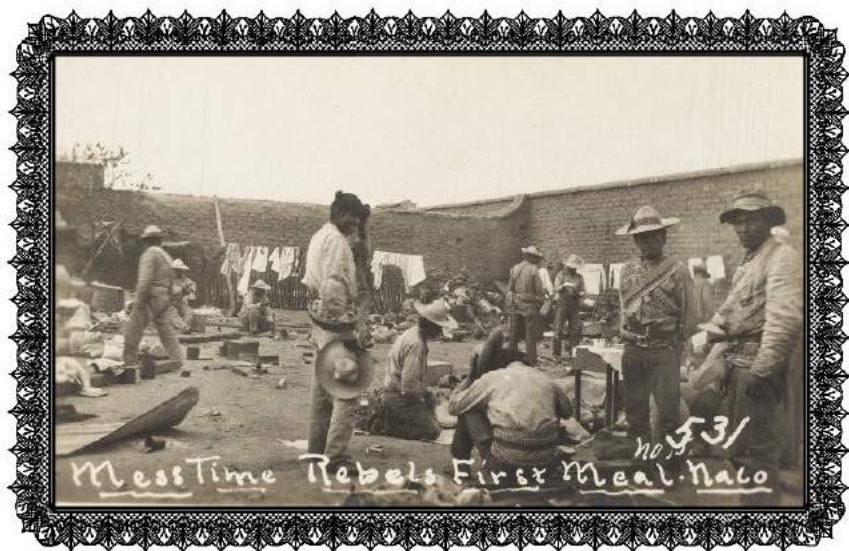


Artillerymen near Naco Arizona. c-1914

the border, including Douglas, and Naco Arizona to protect American interests. A new period of prosperity began for the girls. Thousands of bored, single, young men with steady incomes were now stationed a few miles from Bisbee.

Albeit, battles did occur at Agua Prieta and Naco, Sonora and eventually, Naco, Sonora was under siege for 118 days. Largely, this was a tiresome deployment into the middle of nowhere for most soldiers. Bisbee's saloons and the red-light district were tantalizing attractions.

On January 1, 1915, Arizona became a dry state. The proximity to Mexico provided a supply of alcoholic beverages. By this time, the soldiers were getting into trouble. Soldiers had robbed a couple of red-light girls in Bisbee. Irene Brown was threatened with a straight razor as a tenth cavalry soldier robbed her. At nearby Douglas, Bernard Wilson a member of the Tenth Cavalry was killed protecting a red-light girl on 6th street in Douglas from two other soldiers. Also, the U.S. Army was becoming frustrated with the local law enforcements inability to control illegal alcohol. The U.S. Secretary of War placed the Douglas Red-light District out of bounds for soldiers, but worded it in such a way that it could mean any such district.

In late November 1917, an army officer made a study of the impact of Bisbee's red-light district on the military camps at Lowell, Douglas and Naco. His research revealed that Bisbee's girls often traveled to Douglas and Naco to visit the soldiers. A few weeks later, December 4, 1917, the U.S. Secretary of War sent the City of Bisbee a directive to close the red-light district. The mandate stated that as it



was illegal to have an army encampment within five miles of a red-light district. A detachment of the U.S. Army's 35th infantry was camped, below Lowell about two miles from the ill-famed district.

Pressured by patriotism, the Bisbee city council guided by Mayor Erickson voted to close the district for the duration of what was to become known as World War I. U.S. Army, Lieutenant Poppaneau attended a Bisbee City Council meeting as a representative of the federal government and thanked the city for its cooperation.

The closure of the legal district came quickly and quietly. The ill-famed ladies left Bisbee on passenger trains for other communities. Each train carried a few of the girls. At 2:00 am. on December 10, 1917, the last legal house of prostitution closed its doors. A few ladies remained waiting to leave and sell the gaudy furniture and other fixtures of the district. In contrast to the days of colorfully written



articles of the district. The closure was noted briefly on the last page of the Bisbee Daily Review.

Unofficially, the former district still housed ill-famed ladies. In early 1918, two naive young men went up to the old red-light district to rent a room. They quickly discovered that more than a room was for rent. This led to the arrest of Billie Anderson and her mother Rosa Reed. The reporter for the Bisbee Daily Review found the story of the gullible young men rather amusing. Other women continued to use the former red-light district to conduct their bawdy business for decades after its official closure.

Yet, nearly a decade before its closure the district was beginning to decline. The original community of single, well-paid miners living in the desolate high desert more than a hundred miles from Tucson and fifty miles from a railroad had been replaced by a thriving city of families with street cars, electricity and a railroad depot in the center of town. More importantly the role of women had changed. Suffrage had been adopted in 1915 by Arizona. A minimum wage law of \$10.00 a week for women called the red-light abatement act had been passed in 1917. An increasing number of women were seeking higher education and better employment opportunities were beginning to form.

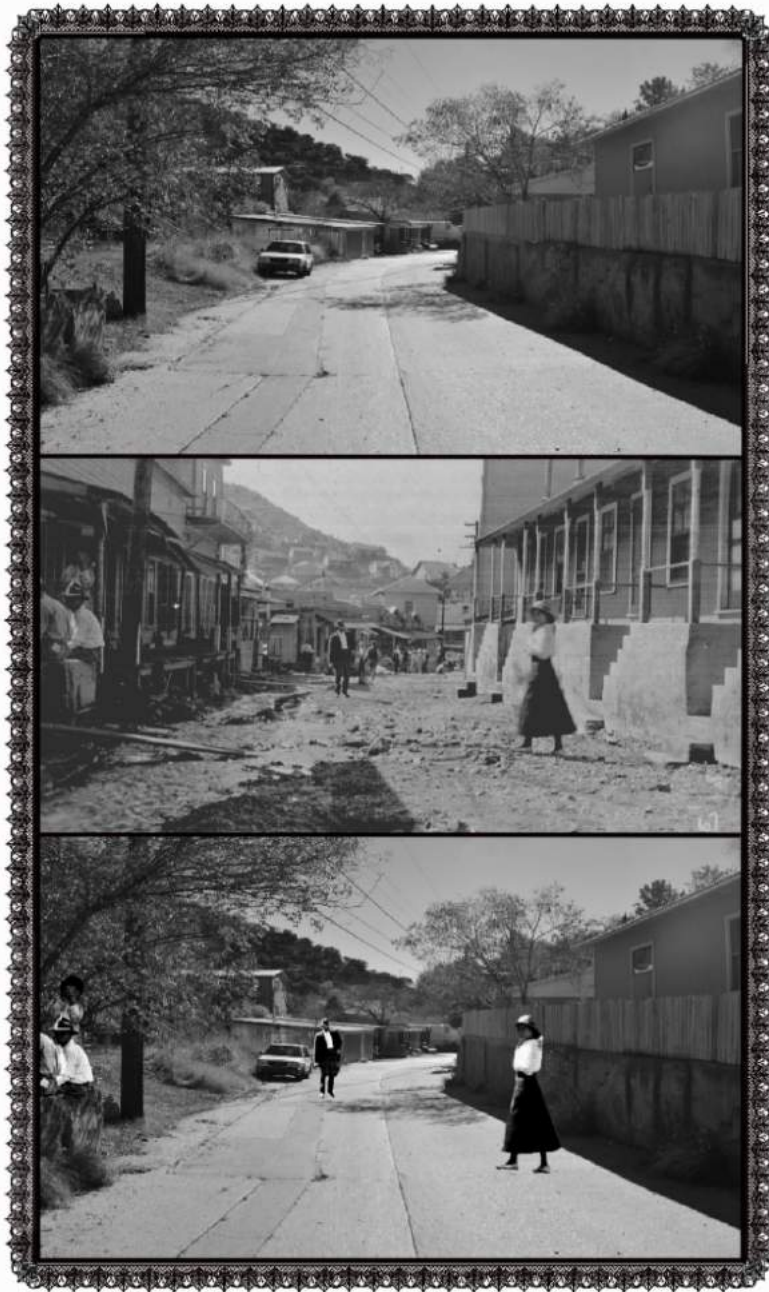
Empowerment of woman was even expressed in fashion. The binding corset which had forced a lady's figure into the desired shape



was replaced by comfortable vertical, free flowing clothes. Stiff high collars and long sleeve gave way to open low curved collars and short sleeves. Significantly more of a woman was now up for show.

Still the ill-famed ladies are an integral part of Bisbee's past. Joe Chisholm one of the men who had experienced the district wrote that *"in the first hectic days of the frontier they were about the only womankind the wild Southwest knew. Perhaps the only kind it could have known."*



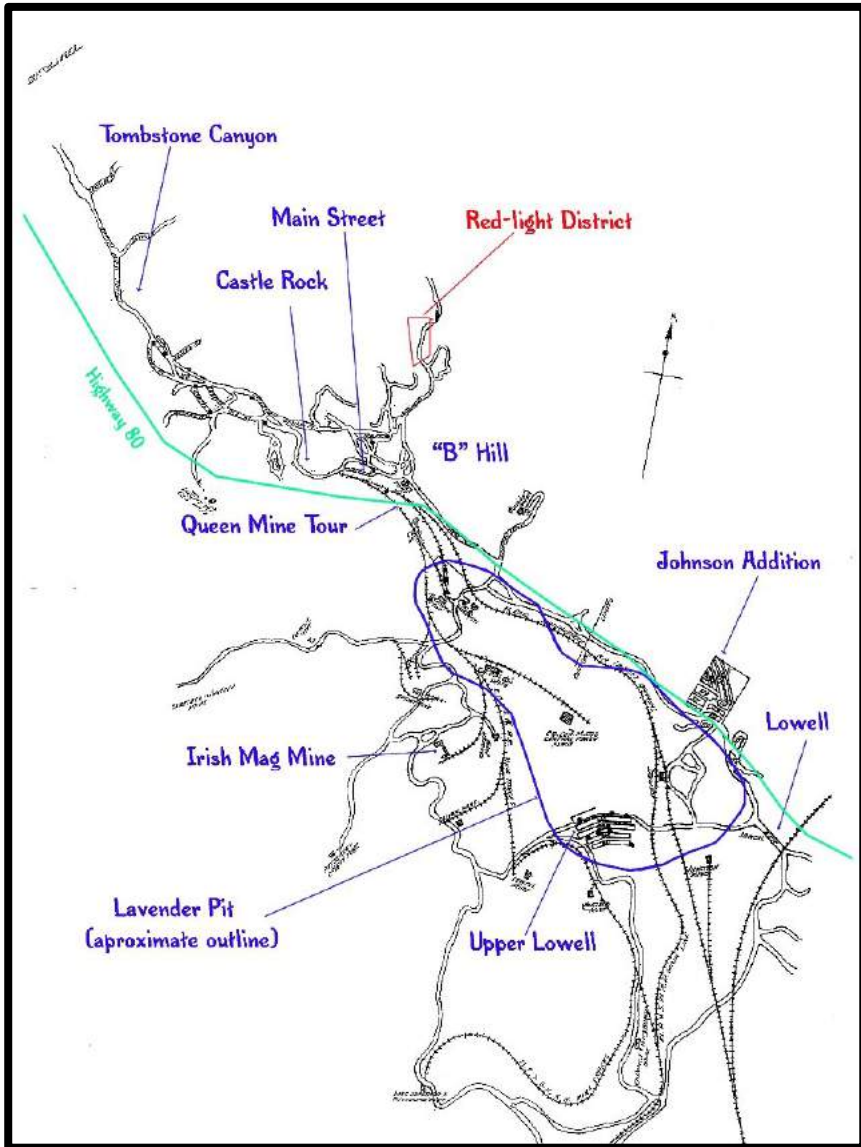


Top: Part of the former red-light district in 2016.

Middle: The active red-light district around 1910.

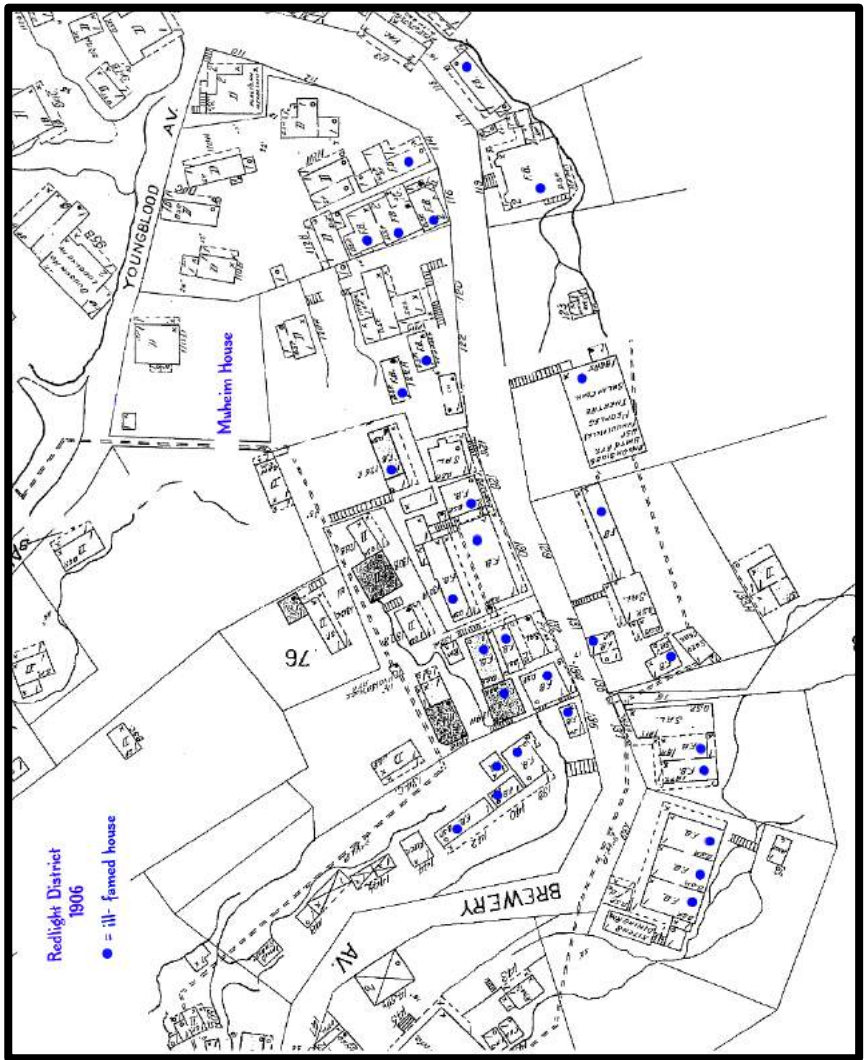
Bottom: A composite of both images showing the placement of main people.





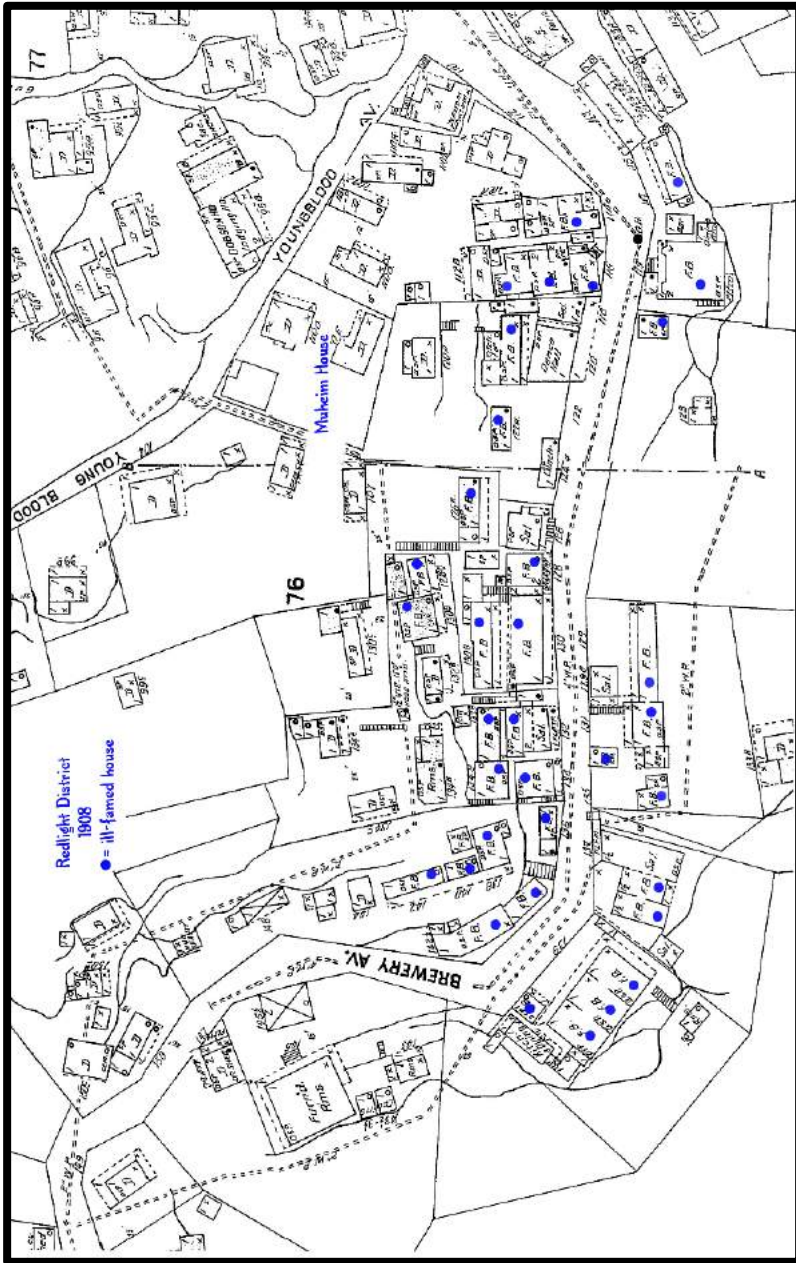
A general map of Bisbee showing the location of the red-light district.





A map showing the known red-light houses active in 1906.





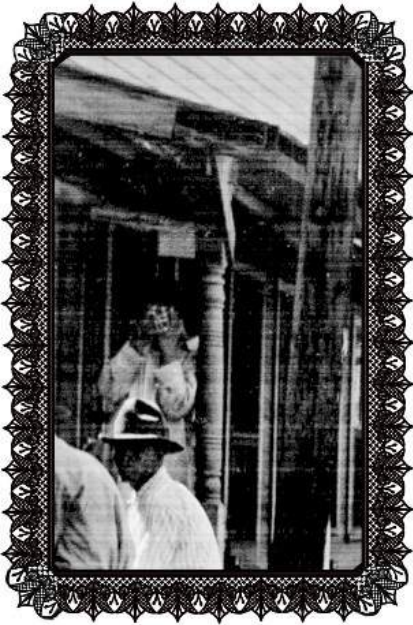
A map showing the location of the red-light houses active in 1908



The Ladies



These are only known images of women in Bisbee's red-light district while it was active. c-1910





History, normally only recorded the rowdy girls. At times the district was home to nearly 100 ladies, but at any given time only about ten are found in primary documents. These are typically, coroner's reports, newspaper articles and judicial records. This creates a tainted view of their history. The majority of the women seem to have lead relatively quiet lives or at least avoided legal troubles. Also, the wonderful and quintessential elements of humanity are normally forgotten. Caring, compassion, kindness and love rarely make history. Yet, a few precious glimpses can be found. In one preserved oral history a woman tells that as a little girl, she remembered the ill-famed ladies purchasing shoes for school children that could not afford them. A coroner's inquest, tells of Ethel Patterson carefully purchasing an outfit of clothes for her son who lived with her parents in the last hours of her life. Even the "wild little animal" Anita Romero is recorded as proudly telling of how her eldest daughter was graduating from high school and would grow up to be a lady.

Money was the largest reason a woman entered the ill-famed life. During 1905, a woman in Arizona could expect to receive about \$1.55 for a day's wages. Miners in Bisbee at this time, received \$3.75-\$4.00 per day. A woman could not expect to earn a living wage as a clerk or waitress. It was expected that she would be dependent on a husband. Teachers were better paid, but required special training and still would have made substantially less than a miner. In 1907, Arizona's teachers made on average \$71.10 a month and at the time they were the highest paid teachers in the United States. An underground miner made between \$83 and \$96, a month. Note, that Bisbee miners were considered the highest paid in the world at this time. It is important to note that these high wages resulted in a relatively high cost of living, thereby putting an additional financial strain on single women who worked outside of the red-light district.

As a lady of the night they could make substantially more income. For sexual services they charged a fee from \$ 2.00 and continued up to \$10.00, if the customer stayed the night. She also, may receive tips a grateful client left. The exact knowledge of income they made on selling drinks and dancing has become lost to time, but was significant. Although, some girls made enough money to purchase diamonds and other fine jewelry, others like Rita Reese were desperately poor. The elite ill-famed houses that catered to wealthy customers seem to have never developed in Bisbee. Photographs of the district reveal it was built of rather modest wood and sheet metal buildings. It is unknown whether specific girls were able to develop a wealthy clientele.

Women came to the ill-famed life by many routes. Some came to escape poverty, others to flee an unhappy or abusive marriage. Still others were forced into the profession by husbands, siblings or even parents. The youngest documented was a 13-year-old girl with flaming, red, hair. Her parents had forced her into the profession, but she later found a level of respectability when she married Emmett Walsh. Mr. Walsh knew of her past but accepted her and actually even gently teased his wife about her illicit past. "*Slivers*" Glover appears to have been forcing a woman to work in the district. He was arrested after a police officer heard rumors that he had told people that he was planning to "*beat her head off*" if she had not made any money. The officer reached the house in the district, just as he was releasing a



barrage of verbal abuse on the girl. Felix Taylor was arrested for prostituting his own wife Harriet. Wife of a popular miner, Mrs. Kathryn Mabry was arrested for trying to lure underage girls into the immoral lifestyle. She offered three young girls an oyster and chicken supper at a home on Naco Road. Mrs. Mabry made great efforts to keep the girls at the house for the entire night. The Bisbee Daily Review reported the young girls even smoked opium. Although, the girls left against the wishes of Mrs. Mabry and did not spend the night, Mrs. Mabry was arrested. At her trial, Mrs. Mabry “ *wore an air of defiance*”, but she was “ *clad in a black skirt and white waist, a black peach basket hat, trimmed with red cherries, set, off her far from bad looks and made her quite a “stunning” figure.*” Mrs. Mabry was convicted of her crime.

About the same, Bisbee was again in an uproar when 16-year-old Lillie Neatherlin was discovered working at No.41. It appears that Lillian and definitely, her sister Della had entered the district of their own free will. Accusations were made that the madam of the house, Mrs. Andy Miller refused to let her leave and she was charging with luring an underage girl into an ill-famed life. The case was dismissed because “ *the cordina (sic) of the girls themselves shows that they were not of previous chaste character and the charge is not sustainable under the express provision of the statue.*”

Underage girls were the exception, most of the ill-famed ladies were from 19-30 years old. Madams were sometimes older, but not necessarily. Anita Romero ran a house when she was 25. Interestingly, the ladies of African descent seem to have been much older. They were typically in their middle thirties.

The girls often adopted alias, nicknames or professional names. For girls like Trixy Fawcett, Lily Silver and Crazy Horse Lil these names became their real names and are found on all official records. Carrie Bush whose actual name has never been discovered was even buried under her alias.



For some like Anita Romero, Ma Reilly, and Crazy Horse Lil the ill-famed lifestyle was a perfect fit. They thrived in the environment. Crazy Horse Lil is described as *“immoral as hell and not a cockeyed bit ashamed of it”* and Anita Romero as *“an animal of the wild.”* Others, like Carrie Bush, Rita Reese and Ethel Patterson were trapped in a lifestyle that led only to unhappiness. Yet, it is noted that the girls of the red-light were to be found in all the varieties and personalities of their chaste sisters.

Although, the majority of the ladies were American born, the district did have its share of sturdy Irish girls like May Gillis and Bridget Gallagher. These blended with the French such as Lily Silver or Marguerite Lefebvre, and the German, Marie Happe. Dark-eyed Mexican beauties formed part of the district’s population as did a large number of ebony ladies of African descent. Rosie Highwarton claimed to be partly Native American. The district lacked the presence of any Oriental beauties.

In 1907, the Bisbee Daily Review noted there was an unwritten law that people of Asian descent could not live in Bisbee. Local legend states that this was because Chinese would open laundries and this was one of the few respectable jobs a single woman could hold. As a result, it was said a Chinese could not stay the night in Bisbee. Exceptions were made for respectable citizens. A number of Japanese engineers were frequent guests of the Copper Queen Consolidated Mining Company from 1900-1917. A Japanese mining engineer, Takeo Shikamura was hired by the Copper Queen and his family did reside in Bisbee from 1909 to at least 1918. For a taste of the Orient, a man would have to travel to the red-light districts a few miles south in Mexico. These districts did employ Asian girls.

Fashion was all important in the district. It was an essential element to the ill-famed business and a times competition was fierce. The earliest scarlet ladies are noted to have observed any ladies arriving to Bisbee to inspect the new fashions popular in the metropolitan areas in the East. The district reached its peak during the early Edwardian period and the “*Gibson Girl*” look was all the rage. A trial at the Justice Court was another reason to dress up in finery and flaunt it to the citizens. “*Justice Murphy’s court room was transformed yesterday into what at first looked like an advertisement for a ladies’ tailor shop. There were loud green suits, creations of dazzling purple and scarlet, with picture hats to match, suits of conventional black and flaming red. The air was heavily perfumed and paint and powder added luminous luster to the countances (sic) of those ensconced beneath the huge millinery creations*”

After 1888, when the railroad came to Bisbee and modern fashions were readily available at both the Copper Queen and Fair Stores. These stores prided themselves in stocking high quality fashionable merchandise.

Religion was not entirely forsaken by the ladies. Although, they may have not been among the Sunday church going group, they at least maintained a connection. Hospital records reveal fourteen girls whose religious affiliation is known. Three claimed to have no religion, three were Protestant and eight were documented as Roman Catholic.

Death ruled the Southwest for decades. Bisbee's water supplies were contaminated not only by outhouses, but by the city cemetery. Typhoid was rampant, malaria, alcoholism and mine accidents all hospitalized and killed a large percentage of the population. The Grim Reaper walked the streets stairs and hallways of the red-light district just as quickly as Main Street. In the harsh reality of early Bisbee, suicide was all too common among miners, gamblers and the ill-famed ladies. Although, Coroner's Inquests reveal these were often desperate cries for help. Too often the desired rescuer, a man that had enchanted one of the ill-famed temptresses never came. Carrie Bush, Bridget Gallagher, Rita Reese, Ethel Paterson and Clara Dodge ended their lives in the district. Each of these girls drank carbolic acid (phenol alcohol). This was commonly used as a disinfectant or took corrosive sublimate tablets (mercury dichloride) a treatment for syphilis. These girls suffered terribly from the effects of these corrosive chemicals before dying in agony.

Not all the red-light deaths were tragic suicides, Helen Tichnor, fell off a porch in a drunken state on the fourth of July 1909. She died from a fractured skull the next day. Grace Calipon succumbed to alcoholism.

The graves that could be located are all unmarked in sections of rocky desert soil with patches of dried brown grass, but they are all in the consecrated ground of the Old Catholic section of Evergreen Cemetery. Also, with at least Rita Reese, a Catholic mass is known to have been said at the funeral. These graves are not isolated by themselves, but rather intermingled among graves of Bisbee's more respectable citizens, such as members of Kinsella and Critchley



families. The graves of Clara Dodge and Ethel Paterson are recorded to be in the Evergreen Cemetery, but could not be positively located. Irene Logan and Grace Calipon are probably buried in Evergreen Cemetery, but records of their grave's locations has faded with time. Hazel Dee is buried next to her husband in Evergreen Cemetery. She died in 1969 in her 70's

Yet, with all their charms the girls of the ill-famed life still were considered second best. It was their "*chaste*" sisters that were preferred by most men. Instead of wild times, they offered the attraction of family, stability and a chance of someone to grow old beside.

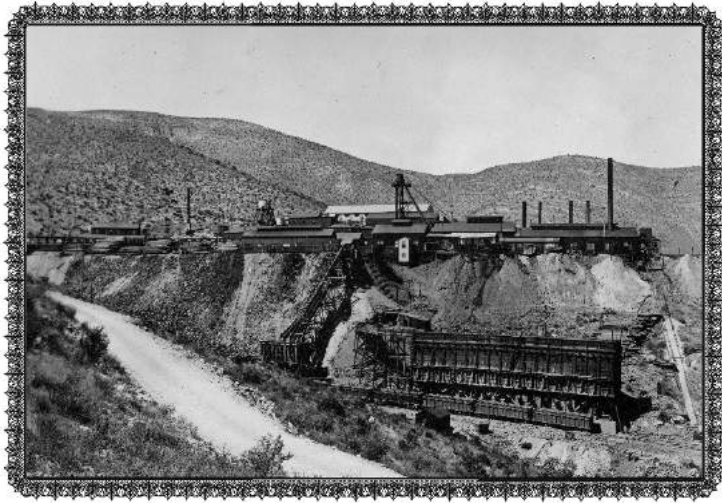


Denizens of the Underworld



Around 1884, the petite and dark-haired Irish Mag arrived in Bisbee. Although, she was probably not the first scarlet lady to come to Bisbee, she is the earliest that history has chosen to record. When she came to the community, there could have been hardly a more desolate and uncivilized place in the continental United States. Renegade Apaches roamed the hillsides hunting and raiding. The community was built of tents and simple wooden structures nestled in the canyon bottom. Crude smelters billowed sulfur rich smoke and the largest structure in town was the hoisting works of the Czar Mine. Here, Irish Mag found a small home on the west end of town with a green roof and next to the home of saloon keeper/ Sheriff Billy Daniels. Outside her residence she kept a green parrot in an oak tree. Passing miners instructed the bird with a “*colorful*” vocabulary. She gained a reputation for compassion when she cared for the body of Sheriff Billy Daniels after he was ambushed and killed by Apaches, a few miles outside of Bisbee. This soiled dove of the high desert permeated the town with her feminine charms. Her allure was strong enough, a prospector named a promising mining claim after her. It is possible that she helped finance the prospect, although there is no documentation. Legends state that she became wealthy from this claim, but this is unlikely. Records do indicate at least three other women did profit from sales of the property. It was not until 1901, the Irish Mag Mine struck its first ore 850 ft. below the surface. Irish Mag herself had long disappeared from Bisbee, by this time. Yet, the Irish Mag Mine blossomed like a cactus flower, filling the community with wealth and immortalizing the fallen woman, Irish Mag.

After, Irish Mag, the ill-famed ladies become temporarily hidden in the shadows of time. Clara Allen started House No. 41 on Naco Road sometime before 1892. This woman came to Bisbee as a wild young lady and stayed to at least 1902, before moving to Globe, Arizona. She is believed to be the longest working madam in the town. During this time, she evolved into a motherly figure who gave maternal and moral advice to the men and women of Bisbee. The lack of information about her house implies was generally quiet.

On May, 7th 1892, the law forming the red-light district in Bisbee came into effect and Clara Allen and the other ladies moved their businesses into Upper Brewery Gulch. The people of Bisbee looked at a red-light district as an unpleasant necessity. It was unrealistic that prostitution could be eliminated in the remote town dominated by single men. Yet, it was desired that the ladies be isolated from residential and business areas. Ill-famed houses were often rowdy and sometimes violent places. At least inside of the city limits the district could be somewhat controlled.

Mother Earth's treasures poured wealth into the community. Citizens began to accept Bisbee was not a boom town like, Tombstone



and the mines were going to prosper long. In 1896, the Weekly Orb newspaper printed its first issue and began to record daily activities that were considered too minor to print in the nearby Tombstone Epitaph.

On May, 11 1899, the worn pebbles of the gulch trickled with blood. That Saturday night, Irene Logan a madam of the red-light district entered the saloon of Dora Garnett (Dora McCrellis/McCillis), another red-light madam. She came bringing with her another woman and a man. These ladies operated ill-famed houses located across from each other on Brewery Gulch. Soon after entering the saloon the intoxicated women engaged in “*sarcastic remarks leading to cutting abuse*”, which was followed by flying lead from a six-shooter. Dora had told Irene and her female companion to leave several times. They initially refused, but finally the one woman left and Irene remained. The abuse continued and Dora pulled a six-shooter from behind the bar and fired twice. One bullet struck Irene in the neck and exited through her back, but the other missed. Irene died shortly after being wounded. The coroner’s jury decided that Ms. Logan had died of murderous intent and Ms. Garnett was held with \$15,000 bail. Soon after being jailed Dora had a breakdown and was transferred to the county hospital where she could walk around freely. The Oasis, a newspaper printed at Arizola, Arizona published, a sarcastic comment about the upcoming trial. “*Some of the most respectable young gentlemen in Bisbee (choir singers, Sabbath school teachers. etc.,) have been subpoenaed to attend the district court at Tombstone next Monday, to testify to the good moral character of Dora Garnett, who will be tried for her life, for killing a fellow cyprian at Bisbee some weeks ago.*” Little is known about the proceedings of the trial, but by April 1901, she had returned and was working at Rose Miller’s Place.

As the turn of the century approached, Bisbee was conquered by the petite dark-haired Mexican beauty known as Anita Romero. She was described as a “wild little animal” with an unrestrained splendor. Joe Chisholm remembered, “Her blue-black hair and shadowed eyes that were flaming glories of dull rose or lances of higher light with her moods, her luminous olive-cream skin that glowed pink or carmine with her flow of wild emotions, the all-around savage charm of her suggesting some strange barbaric strain,”



Before Bisbee, she had traveled from Zacatecas, Mexico through the famed mining camps of Chihuahua, Cananea and Minas Prietas, but as with most of her profession she was a wanderer, staying only a short time at any given place. Anita began operating an ill-famed house and saloon as turbulent as her personality in late 1899. She first became entangled with the law in January 10, 1900, when she fought with another red-light girl, Juana Barba. Both ladies were intoxicated and they were fined and released.

First blood was spilled at Anita's place on April 29, 1900. Juan Valdez entered her saloon and Guillermo Fredrico was tending the bar. Valdez spent \$9.00 on drinks and then asked to be given a room. Fredrico helped him to a bed. Then around 4 or 5 o'clock the girls of the house complained to Anita about him and she went to check on him. He was vomiting and asked her to bring him two drinks. She told him to see the bartender. He told her *"You whores have beat me out of this money, or beat me out of some money."* Anita told him that her girls were honest and never robbed anyone. Then, Anita questioned him if he had money, why did he asked for \$1.75. Valdez told her, *"You pay me or this man Guillermo will pay me."* She responded that she would talk about it after he was sober. The discussion continued and became verbally abusive and he finally left. At 8:30, Anita's place was filled with music and crowded with people and Juan Valdez returned. He stepped up to the bar and said, *"Here you pimp (palo blanco)"* *"Neither you nor your whores are going to rob me out of a cent."* Anita was standing by the stove and said *"The bartender has nothing to do with the whores; I am the one who attended to them, and if you have anything against them you should talk to me about it"* Valdez left the bar and closed the door. As he left he told Anita, *"You will see if you have any money or not."* He stepped back into the saloon and tried to shoot Anita. She was standing behind the bar. After the shot, Anita hid behind a demijohn. The other witnesses stated that Valdez tried to pull out a pistol, Fredrico shot first and Valdez's shot went through the roof. Firing continued back and forth. Anita



stated, it seemed like she heard thousands of shots. The Americans in the house broke a window and went to get help, but one was shot in the hand. Estafina one of the girls was wounded. A man named Hulo (Julio?) took a bullet in the leg. Valdez reentered the saloon and moved towards the bar and was finally shot by Fredrico when he was about 4 feet from the bar. Valdez fell and began randomly shooting until he died. Pedro M. Garcia claimed that Anita fired twice at Valdez after he was down.

On December 18, 1900, Rosario Tapeta a man with a crippled hand was singing and Pedro Ariola was following along with a guitar outside of Anita Romero's Place. Then men went into the bar and had a drink and began quarreling in Spanish about a woman. Anita told them both if they wanted to fight to go outside. Pedro left and Rosario left about five minutes later. On the gulch the men met and began arguing again. Pedro pulled out a black-handled revolver and shot at Rosario. Rosario turned and tried to go back into the saloon. Two more shots were fired and Rosario fell. One bullet hit his collar bone, but was a minor wound. The other passed through his lungs and liver and proved to be fatal. Her house's reputation failed to improve.

The local newspaper responded by reporting that her bawdy house and saloon was frequented by a rough group of Mexican railroad men. Furthermore, it recommended it be shut down and claimed that the house cost the taxpayers hundreds of dollars a year in court fees. This was far more than her license fees. Less than a month later, violence again broke out at Anita Romero's place. Anita Romero heard that four men were headed up to her house and "*clean it out*" She told Deputy Constable Francisco Jurado, who was at the ill-famed house, about the predicted trouble. This deputy had been stationed to watch over the ill-famed houses and prevent trouble. He called Constable M. Doyle for assistance. Abundio Salas and Reyes Bustamante were there and had become "*insulting and abusive*". Jurado searched the men and found no weapons. Constable Doyle and Deputy Constable John M. Johnson arrived and found no immediate



problems and told Jurado to keep order and arrest anyone making trouble. Doyle and Johnson left. As they passed the Shattuck lumberyard they heard four shots coming from Anita Romero's. They arrested a man running down the gulch and then found Jurado standing over the body of Abundio Salas, which was lying in the road. After Doyle and Johnson had left, Abundio and Reyes became abusive to the bartender and customers. Deputy Jurado, suggested to the men that they should go home. The men then began to shower the deputy with profanity. Jurado removed the men by force and arrested them. As Jurado was walking behind the arrested men in the darkness down the gulch, suddenly, Reyes punched Jurado and Abundio pulled out a .38 pistol and fired twice at the deputy. Jurado fired his .44 pistol once striking Abundio in the chest. As he fell, Abundio, fired a final shot and died quickly. Reyes Bustamante was arrested and fined \$10.00, but did not have the money and spent the time in jail.

On March 1, 1901, Constable Johnson went up to Romero's to remove a drunken man, when he was jumped by the ladies of the house. Defeated he retrieved a gun and Constable Foster. The men arrested the women, but other than this the ill-famed house was quiet. Soon after this Anita Romero, the woman whose beauty made a man's blood boil, left Bisbee for the booming community of Cananea, Mexico.

A contemporary to Anita Romero was Mary Geary. This woman of African-American descent opened a house in Bisbee around 1897. Like Anita she operated a saloon connected to an ill-famed house. Other African American women worked at her establishment, like Emma Prather and Emma Hudson. A Miss Beach also worked for her, but her ethnicity is unknown. Regardless, her establishment served everyone and was frequented by "*Americans*" and Hispanics. On March 21, 1901, violence erupted at her house.

Sometimes there is thin strip of lace and a trickle of whiskey, between a law keeper and a law breaker. Deputy Constable and Deputy Sheriff John M. Johnson were headed up the gulch with John



Foster. They were warned than Francisco Jurado, a former deputy was at Mary Geary's place and had struck a man with a gun. He was acting wild and was likely to kill someone. Deputy Constables John M Johnson and John Foster were on their way up the gulch and Emma Hudson, a lady from Geary's house told Foster that Jurado was at Geary's house and "*raising hell.*" Foster and Johnson walked to the house and could see Jurado sitting at the bar. The lawmen saw him get up and tell one of the girls that no one could ever arrest him. Jurado then left with three other men and headed towards Anita Romero's. The deputies decided to wait to arrest Jurado, because of the likelihood of an innocent bystander would be killed or injured. Johnson continued up to Rose Miller's Place, while Foster walked through Mrs. Geary's Place. One of the girls told Foster, she was afraid Jurado was going to kill her. He told her to get him if Jurado came back, then Foster went to Rose Miller's place to get a drink. As Johnson and Foster were being served their drinks, Emma Hudson came and told them "*For God's sake come over, come on as this man that is there is going to kill someone*". She also warned them to allow Deputy Foster to enter first as Jurado was likely to kill Deputy Johnson on sight. Johnson went into the parlor and picked up his shotgun and both deputies headed to Geary's. They found Jurado leaning on the bar with his arms and told him to hand over his gun. There was a small scuffle. Johnson pulled Jurado down and Foster took his gun and put it in his pocket. As they were walking Jurado, asked Foster to loosen his grip on his arm. As soon as Foster loosened his grip, Jurado grabbed his gun from Foster. Foster shouted to watch out. Jurado turned and cocked the pistol and Johnson fired killing Jurado. By 1902, Mary Geary appears to have left Bisbee.

In December of 1901, Cora Miles purchased a property in Bisbee for \$500.00 from John Reilly. This was likely "Pa" Reilly of the couple "Ma" and "Pa" Reilly who operated an ill-famed house on the gulch. "Ma" had been adopted as a child by a family who ran an ill-famed house and even though she was raised in that environment, she



remained an unprofane, sober woman and true to her husband. She considered ill-famed houses her “*natural range*” of existence and felt she was meant to run a house. They had had ill-famed houses at the nearby Ft. Huachuca and Gleason, Arizona before settling in Bisbee. They had a reputation for caring about the girls who worked for them, feeling that they had only become lost along life’s trails and were not truly bad people. They brought respectability and a “*Practical Christianity*” to the brothels.

Unlike, the Reilly’s Cora Miles stood her ground firmly and was not hampered by morality. Although, her ill-famed house never was as lethal as Anita Romero’s it was far from peaceful. A good part of the violence stemmed from Cora herself.

At 4:30 am on May 23, a typical red-light brawl broke out at Cora’s house between Sydney and Grace Chase with Lillie Evans. Grace struck Lillie’s head with a water pitcher. Leaving her covered in blood. Evidence must have indicated the guilt of both Grace and Lillie. They were both fined \$5.00 each.

A few months later, Cora had Dolly Dunbar (Monbar) and May Hines arrested for throwing rocks at her establishment. A number of girls were drinking wine around the house at the time and it could not be confirmed that Dolly had thrown any rocks. Dolly, testified she was holding a bottle of Mumm’s Extra Dry (champagne) and could not have thrown rocks. In true red-light fashion most of the witnesses failed to show up for court, so the city profited after Justice McDonald fined the absent witnesses \$2.50 each for contempt.



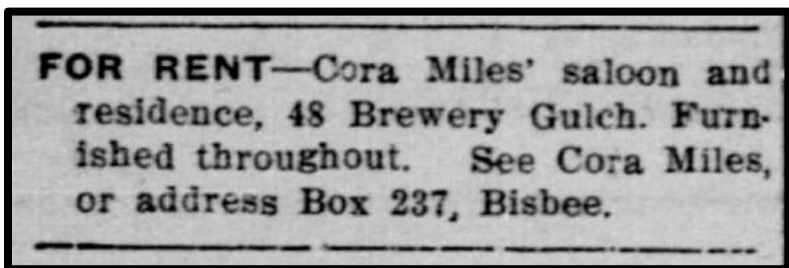
August 3, 1903 a complex chain of events began. Cora attacked one of her girls, Phyllis Sherwood with an ice pick. Phyllis was wounded twice in the face, but Cora had a hand broken in the dispute. A few days later, Cora was arrested for assault with a deadly weapon. The case was later dismissed when it was revealed that Phyllis had attacked Cora with a beer bottle and Cora had only defended herself. At the same time Phyllis Sherwood and fellow soiled dove Sybil La Verne were arrested for allegedly stealing \$575.00 in cash and bank certificates from customer, Bert F. Noftz on the night of August 4th. Cora Miles was the primary witness against the girls, but the evidence provided by Cora and the other witnesses was weak and the girls were released. As Noftz left the court room a man approached him and asked him if he was the man, who claimed the women had stolen money from him. He said, "Yes." and the man struck him a severe blow with his fist. The rumor went around town that Noftz had been stabbed, but this was untrue. Noftz continued to visit Cora's House and became involved with an ill-famed lady, Mabel Carlise who worked at the house. Noftz, Mabel Carlise and Johnny James met at the Wave Candy Parlor with a rented carriage. On August 19 at 12:50 am, Noftz and James entered the St. Louis Beer Hall with their faces covered with masks and guns drawn. They ordered the occupants to raise their hands, but the robbers were nervous and shot and wounded bartender Otto Schmidt. When roulette dealer L.O. Milless walked through a door he was shot and killed. Noftz and Ms. Carlise left Bisbee for Cananea, Mexico in the rented carriage. In Mexico, Ms. Carlise changed her name to Mabel Pearson. Bert Noftz, had been left in charge of the Opera Club House, while its manager was on vacation. During this time, Noftz had been spending club house money on Mabel Carlise in the red-light district. It was felt that Noftz had accused Phyllis Sherwood and Sybil La Verne stealing money from him to cover up his own theft of the Opera Club House funds. Noftz was sentenced to seven years in prison and was released after completing five years. Johnny James was not convicted for his part and Mabel Carlise was never tried.



The activities at Cora Mile's House were quiet only for a couple weeks. On September 3, 1903, a deputy sheriff was searching her house to locate a watch that was believed to have been stolen from one of her customers. Under a bed in an upstairs room he discovered almost one pound of opium, a full layout with an opium pipe and needles. At the trial, most of the witnesses failed to provide significant evidence. This may have been due to the fact the majority of the witnesses were girls employed at the Mile's house. Pearl Philips had told officers that she had seen Cora and Joel Gibson smoking the pipe, but was struck with sudden amnesia during the trial. The case was dismissed and Cora's attorney insisted that the opium and pipe be returned to her.

The Cora Miles House mellowed for a time. At 2:00 am on November 29, 1903, a drunken Charley Coles proceeded to break all the glassware he could find and then continued to shatter the mirrors located behind the bar. The ladies of the house fled and the Coles stayed on the front porch until he was arrested.

By this time, Cora's success as a madam was in decline. In April of 1904, she was accused along with Goldie Allen of embezzlement. It is believed the case was settled out of court. By June 1904, the Cora Miles Saloon and red-light house was published in the classified ads for rent.

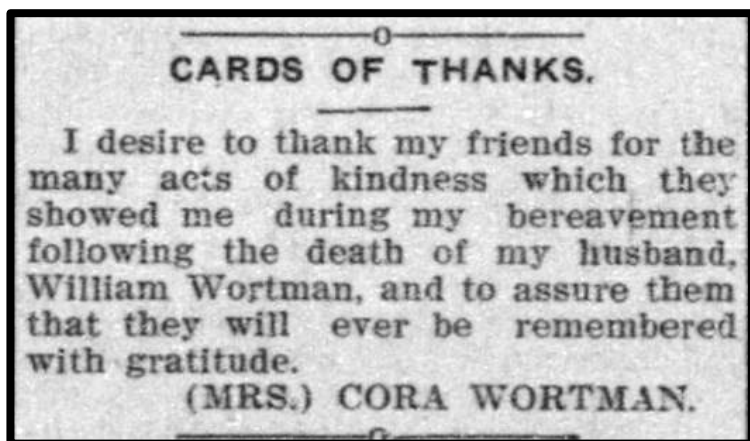


Advertisement, Bisbee Daily Review, June 5, 1904

Annie Levoie rented the property. Cora left town and married William Wortman. She adopted the name Cora Wortman. During October



1905, she was accused of robbing C. Willis of \$700.00 in the red-light district at Phoenix, Arizona. She was arrested in Tucson, but months later the case was dismissed because the primary witness another red-light girl's testimony did not match the statements she had made earlier. Cora returned to Bisbee in 1906 and brought a suit against Annie Levioe for unpaid money. Cora and William did operate a business in the Upper Brewery Gulch as late as 1908. It is unclear of the nature of the establishment. It is possible it was a respectable commercial business. The couple were accused of defacing an American flag as they had attached words to the bottom for an advertisement. Both of the Wortman's were later cleared of these charges. Difficulties continued for Cora. William died on July 20, 1908 from consumption at nearby Benson, Arizona.

After this, a number a lawsuits against Cora mounted. Each of these were for default of debt. Her property was sold in 1911 at a sheriff's sale for \$2,700.00. The troublesome Cora Miles then disappears from Bisbee history.

In November of 1903, Bisbee was introduced to one of its least popular residents and operators of #27 an ill-famed house, Con



(Cornelius) Shea. Shea and his wife Lillian Shea (Lillian Howard). They had come from Jerome, Arizona, where Con had been employed as a bartender. Soon after coming to Bisbee, he was arrested and fined \$7.50 for assault and battery. The violence continued and at 11:30 pm on February 26, 1904, he became engaged in a disagreement with his wife in the red-light district. The resulting fight ended with Con kicking his wife in the head until she was reported to be unrecognizable. After being released on \$300 bail he returned and assaulted her again. Con was re-arrested and released on \$1000,00 bond. In the following days, the Bisbee Daily Review published a series of scathing articles about Con Shea.

“This fiend in human form, is unfit to walk the same streets trod by little children. He is bereft of all decency and manhood and jails were built for the expressed purpose of keeping such as he.” The article ended with *“... This creature confined away from the sight of honest men, in whose nostrils he has become a continual stench.”*

March 1, 1904, the day of Con Shea's trial the Review published an article titled, *“Bisbee is on Trial.”* In this firm article the Review made their opinion well known and advised the jury to, *“Do your duty gentlemen.”* Con was convicted, even though his wife testified that the injuries were caused by a door. The Bisbee Daily Review published a thank you notice naming each individual juror. Shea was given sentence to pay a fine of \$300 or 300 days in the county jail.

Lillian Shea was not the kind of woman to passively accept her situation. On December 15, 1904, she stabbed Con with a knife. The blade's deadly course was altered by a rib and saved Con's life.

New Years Eve 1905, an ill-famed girl known as Carrie Bush walked up to the bar next to Lillie Shea and ordered a lemonade and mumbled something about not living until 1906. When her lemonade arrived she swallowed a handful of corrosive sublimate tablets and washed them down with the lemonade. A doctor was called and her stomach was pumped. She lived for a time, but made it clear that if she survived, she would only try again. Con Shea tried to learn what her real name and where her family was, but she would only say, *“I*



am plain Carrie Bush and when I die, bury me in the Potters Field.”
On January 9th, she succumbed. True to her wish she presently lies in a barren unmarked grave in Evergreen Cemetery.



Funeral Record for Carrie Bush

W.K. Lee sold his "house" in Lowell to Con Shea in November of 1905. It is believed the Shea's moved their ill-famed to outside of Lowell, Arizona at this time. The fledgling community was less than thrilled with the new "business" addition. Trouble soon followed. On November 23rd William Nichols assaulted Con and gave him a black eye. Two weeks later, the false rumor spread through Lowell that Con had been shot and killed. The Christmas Season



continued to be exciting for the Shea's. Early in the morning on December 23, two men entered the house at 3:00 am wielding six-shooters and their faces covered with handkerchiefs and ordered everyone to put their hands up. They immediately walked up and took a gun that the Shea's kept hidden under a towel at the bar. This indicated that the men were familiar with the workings of the house. After securing \$75.00 the men backed out of the house and made their getaway. Later, Charles White and William Rogers were arrested for the hold-up. The men were later released for lack of evidence.

In February 1906, Lillian's temper flared. Con had become too friendly with the house merchandise and Lillian smashed him on the head with a beer bottle and knocked him unconscious. She continued to beat him in his comatose state. A reporter from the Bisbee Daily Review called the house many times trying to get information about the fight. Each time a different girl answered the phone and stated she was busy and could not answer questions. The Shea house had developed a reputation as tough house and a petition had been raised to have its license revoked.

The Shea's appear to have quieted down, until May of 1912, when Lillian had Con arrested for insanity because he was attempting to hurt his family. The charge was later dismissed. After this, the Shea's fade from Bisbee history. Cornelius Shea is believed to have died in Jerome, Arizona in 1913. How Lillian spent the remainder of her life is unknown.

In September 1907, J.H. Brown and Mrs. Annie Hooper were arrested in Lowell. Mrs. Hooper was charged with running a disorderly house and Mr. Brown was charged with vagrancy for living in a red-light house. They were held in the two-story jail in Bisbee. Upon release, Mrs. Hooper returned to the cold concrete and steel of the jail with a judge. This time she wanted to marry Mr. Brown. The constables seem to have little issue with the wedding and were willing to allow Mr. Brown out of his cell. A small crisis occurred when no one was willing to step up and give away the bride. "Frijoles" a local drunk and petty criminal with a reputation of spending more time in jail than out, rescued Mrs. Hooper. He gave the ill-famed bride away to the awaiting groom. After the ceremony Brown was locked up in his cell. Interestingly, Mrs. Hooper was 12 years, Mr. Brown's senior. J.H. Brown was 23 years-old on his wedding day.

Jake Kerner, operator of an ill-famed house known as No. 128 entered another red-light house. The establishment was known as the Canadian Club in Brewery Gulch and he wanted to play dice. It was September 19, 1908. At a nearby table Glen Langford was sitting down to play a game of poker. It was between 3 and 4 am. Former Constable and part owner of the Beer Garden in Lowell, Henry Hall entered the club. Hall was there to pay Harry Miller \$25. Langford asked Hall to play poker and Hall declined. Offended, Langford wanted to know the reason why and Hall told him, *"If you want to know so bad, Langford. I will tell you. You have the reputation of being a cheater and I don't care to play."* Enraged at being called a cheater, Langford began a tirade of accusations and cursing towards Hall. During this entire time, Langford had a hand in his right pocket, grasping a .41 caliber double-barreled derringer. Finally, Langford said, *"Anybody who says I am a cheater*



is a god-damn-son-of-a-bitch-liar” Langford put a foot on the seat of the chair he had been sitting on and said, *“let her go as she looks, if you want to go on through with it, go on.”* Hall drew his gun and fired hitting Langford who turned. Then Hall fired a second shot. Mortally wounded Langford fell to the floor of the saloon holding the derringer. As his body was rolled over to treat his wounds, the gun fell from his grasp and George Ball picked up the pistol. Ball handed the gun to Ollie LePaige, the Canadian Club’s piano player. Ollie placed the derringer behind the bar. When Constable Twomey asked for the gun later, LePaige initially denied there had been a gun. After about a half hour discussion the constable convinced LePaige the seriousness of hiding the weapon. Glen Langford died at the Copper Queen Hospital on September 20th, 1908. The inquest determined that Hall killed Langford in self-defense.

On September 7, 1909, the district livened up with fight between Lena Frush and Millie Brown. Jake Kerner and Jake Miller were nearby and when Millie began to get the best of the battle and gave Lena a firm blow to the lip. Kerner a companion of Ms. Frush, foolishly tried to intervene. After breaking up the initial fight, the brawl brewed up again and this time Millie was scratched around the face, struck on the head and kicked by Jake Kerner, *“where the sun don’t shine.”* In truth, all were losers and each paid fines. Kerner paid \$30, Millie \$25 and Lena paid \$15. The Bisbee Daily Review reported, *“The trials were made the occasion for a parade of the painted denizens of the underworld and two or three of a choloate (sic) shade, most of them together with a number of male hangers-on, being requires as witnesses. There was a dozen or more witnesses in each case, and to the casual-spectator the courtroom and clerk’s office, where the witnesses were herded, presented the appearance of a tenderloin convention headquarters.”*

In less than a month, Lena found herself in *“wild and wooley hair-pulling match”* with Helen Blanchard. Helen owed Lena one dollar and on October 26, 1909 Lena asked for the money. This angered Helen and she stewed in anger until 2:00 am and she went to Lena’s and broke down the door. She then proceeded to drag Lena out

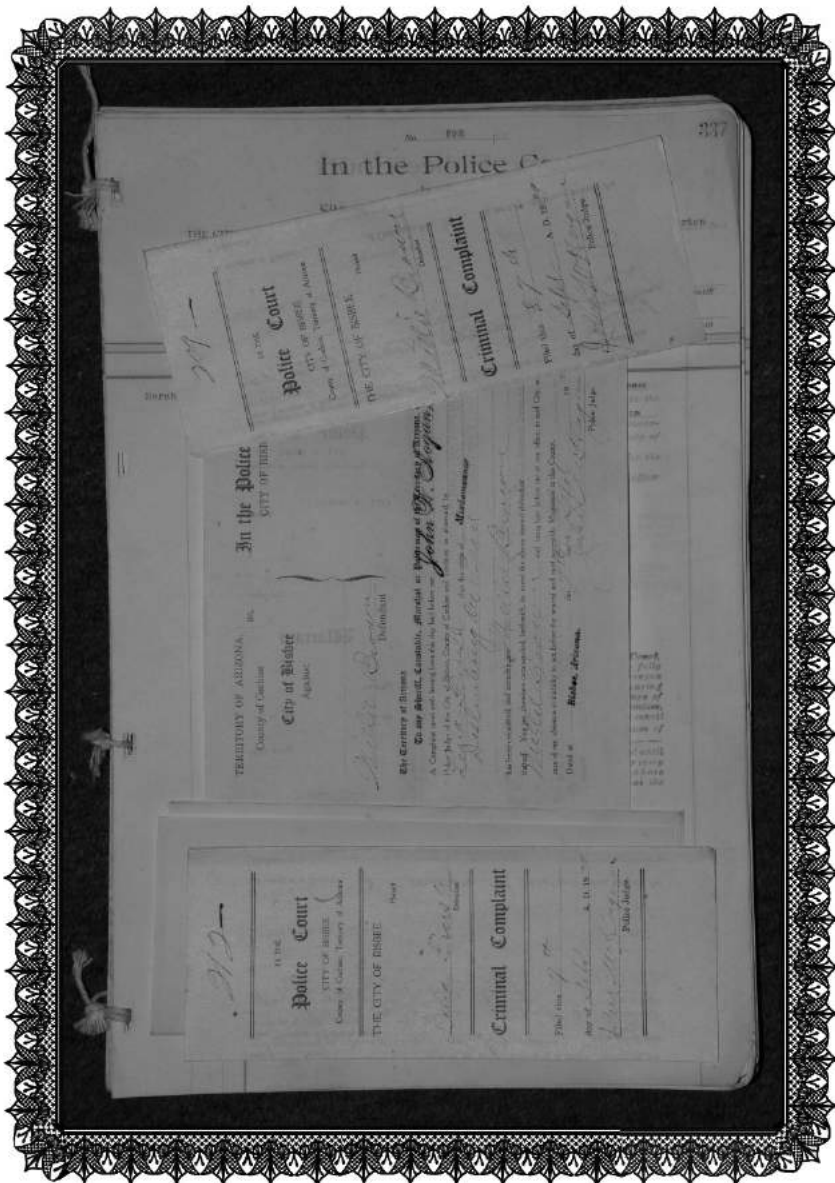


of bed, yank her hair and pound on her with rocks. This continued until Lena was “unable to navigate” For the trial the next day, Lena had to be transported to the court by a hack (passenger wagon). Ms. Blanchard plead guilty and was given a hefty \$50 fine.

Around 1903, Dollie Knapp began working in Bisbee's red-light district, under the name Dolly Monbar. Generally, it was the customers that discovered themselves with their valuables stolen in the red-light district. But on July 30, 1903, Dolly Monbar's ill-famed house was robbed and \$350.00 was taken. Dolly was at a neighbor's resident and was clueless to who had committed the crime. Officer Casad did locate a suspect who had tried to pawn a ladies watch, but Miss Monbar stated it was not hers. Initially, money was often an issue with Dolly Monbar. At first this western Aphrodite gets into difficulties by not paying for cigars she purchased from the Las Dos Naciones Cigar Factory at Nogales, Arizona. The following year, A. LeRoy a dry goods merchant, sues her for \$118. Dolly was taken to court and tried to get the judge to release her from the debt, because she was a single mother raising a son. Unfortunately, for Miss Monbar witnesses proved, the child actually belonged to her sister. She was held responsible for the debt. Her house appears to be relatively quiet. On August 10, 1905, she marries Thomas Alexander Dunbar and her name changes to Dolly Dunbar. The quiet times ended on August 8, 1906. Violence erupted in her house, No.41. This night, a drunken Ed Shearer asked Dolly if he could lie down and sleep on her couch in the bar room. Later, Jake Miller came in and pulled him off the couch. Dolly told him to leave the drunk man alone. Miller began using foul language and threaten to "*clean the house out.*" Dolly's husband, Thomas went outside onto the porch steps to help in the situation. Jake threw a rock and struck Thomas on the jaw. He fell to the ground, unconscious with blood pouring from his mouth. Charles Madden began hitting Dolly and one of her girls, Fay Ellison smashed Charles with a chair. Marie Eddy was awoken by the disruption came onto the porch and was cut by a thrown rock. Thomas Dunbar suffered a broken jaw and a tooth broken in two. At the trial the defendants, Jake Miller and Walter Malen claimed they saw Thomas fall, but did not know why. Then they were suddenly attacked by four or five girls of the house wildly swinging chairs. As part of their story they claimed Thomas was drunk, not realizing he abstained from alcohol and could not be inebriated. Attorney for the defense J.W. Ross closed with



argument “*in which dwelled on the character of the women who were in the case and endeavored to discredit their testimony.*” At the end of his argument, a man named Olsen who was watching the proceedings began supportively clapping. Olsen was taken to jail for this inappropriate outburst. Dolly’s house remains subdued for a time. In June 4, 1911, trouble arises and an enraged Dolly tries to cut the throat of a customer, George Reardon with a straight razor. Luckily, she missed and only seriously sliced his leg. It required 17 stitches to seal the wound. The dispute was caused by Dolly’s jealousy over Reardon’s “*faithlessness*” Her case was initially submitted for Grand Jury, but in December 1911, it was rejected. Thomas Dunbar is granted a divorce for infidelity in July of 1911. On June 18, 1913, Thomas Dunbar died in Bisbee from heart failure. He was at 36 years old and is buried at Evergreen Cemetery. It is unclear what happened to Dolly. It is likely, she left Bisbee and was working in a house called No.12 at the red-light district at Tucson in 1912.

A group of feisty hard-fighting girls appear in Bisbee’s history around 1910. These were Dora Tyson, Hester Parker, Tempest Wyland and Marie Happe. During the night of May 5, 1911, a war broke out between two houses in the district and these ladies were active participants. It was settled when Dora Tyson and Marie Happe were placed under a \$500 bond to keep the peace for six months. After the battle the newspaper reported, “*Only the perfume of a dozen different attars remain in the court rooms as a reminder of the redlight war.*”

Hester had a reputation for trouble and was arrested every few months. First, Hester was arrested in 1909 for fighting with Marie Gusten. She was arrested again trying to remove her luggage from ill-famed house known as No.33 while there was a lien on her belongings. Dora Tyson made the complaint against her. March 29, 1911 was theoretically a wonderful day for Ms. Parker. The 22 year-old married Frank Haywood, a man 11 years her senior. Dolly, Dunbar and George Reardon were the witnesses to the marriage. Their happiness was short-lived. On June 4, 1911, she was fined \$10.00 for fighting. Then nine days later, she learned her husband Frank



Hayward was going riding up to the Divide with another ill-famed lady, Mae Scott and a man named Davis. Hester rode a horse, recklessly through the city with a revolver hanging by her side. She caught up to the riders at the Divide and saw Mae lay her head on Frank's lap. Hester fired a shot at Hayward. The bullet missed and the gun was seized from her. All the bullets were taken out and the gun was tossed into the canyon below. After this Hester retreated back to town. According to the Bisbee Daily Review, when Officer Parley McRae arrested her she told him "*She wanted to, "fill the _____ full of lead."*" At the brief trial Hester stated that she asked Hayward to choose between herself and Mae. Her husband had chosen Mae. She was supporting a six-year-old son and because of this the attorney convinced the Judge Burdick Hester could not be convicted by a grand jury, she was acquitted. The following year she became entangled in a brawl with Fay Greer and was fined \$7.50. After this she recedes from Bisbee history.

Mae Scott becomes embattled in a "*glass and head breaking affair.*" with Molly Jenson in 1912. Although, it is settled with court fines, the Bisbee Daily Review suspected more trouble and describes it with a colorful euphemism;" *The two tribes of Apaches in the district are said to be at each other's throats and further outbreaks are feared*". Yet, the district generally, remained calm. That is until February 21, 1914.

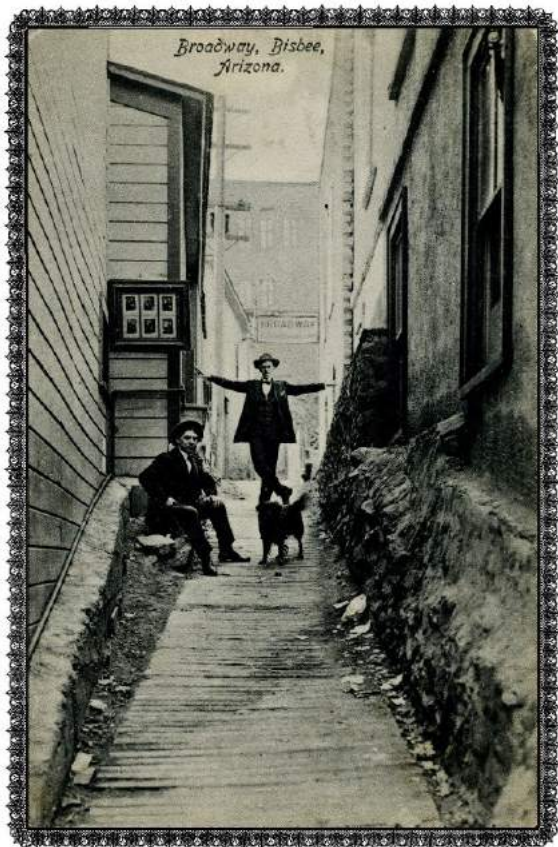
The night of February 20th, Joe Oliver a bootlegger from Oklahoma, spent the night with Mae and left the house in the morning. Mae's husband, C.H. Smith a miner became concerned by Oliver and thought she needed to leave the ill-famed house. Smith began packing Mae's belongs. He was right, trouble was brewing. After leaving Mae, Oliver went to Uncle Sam's Pawn Shop and rented a pistol. When he returned Smith was still packing and Oliver called him outside. On the porch and under gun point, Smith was told to descend the steps. At this point Oliver shot Smith in the arm. According to the Bisbee Daily Review the bone was shattered and the arm was hanging only by the flesh. Joe ordered Smith to tell no one of the incident or he would come back and kill Smith.



Oliver was temporarily arrested by Officer Walter Brooks. Brooks noted, that Oliver was a cool character and mentioned to him about how much trouble he was in. Oliver responded *“Yes, it is a tough hole to get into, but there is always a way out.”* The officers failed to carefully check his belongings. He had a hack saw! At 2:30 am, on February 22, the officers discovered a hole in cell door of the county jail. Three iron bars were cut off and four prisoners missing. Three men with short sentences remained in the jail. It is believed that the saw was in a purse that belonged to Oliver that contained five dollars and personal papers. Oliver had requested from Judge High that he be given them. Two of the escaped prisoners were jailed drunks and were quickly captured at Naco trying to cross into Mexico inebriated. Joe Oliver and J. Hamilton Evans were never apprehended. Although, it is not believed they went into Mexico. Oliver was described as *“a man about six feet in height, his face very wrinkled, and carrying a worried look. He wore a large hat and a gray shirt.”*

May Gillis first appeared in Bisbee history in 1905, when she attempted to commit suicide at the Elite Lodging House. As was common at the time, she drank carbolic acid. Her subsequent screams of pain drew attention and her life was saved. In 1912, attention was again drawn to her when, she was arrested for operating a house of ill-fame on Broadway. Broadway is a narrow pathway between buildings that was used by school children to climb up from Brewery Gulch to Central School. The house of ill-fame was only 150 ft. from the school.

May received a 60-day jail sentence and Victor Ritner the man arrested with her, had his case dismissed. Ritner was a miner for the Calumet & Arizona Mining Company and except for being injured a few times in the underground mines never was mentioned in the newspapers. That changed after he began spending time with May Gillis. Briefly, they tried to charge Ritner with "*white slavery*" then it was changed to adultery, but the case was dismissed. May was released from jail and she chose to use her time poorly. In August 1912, she tried to shoot Ritner with a revolver near the Sacramento Shaft in Upper Lowell during an argument. Victor took the gun away from May. Both May and Victor were arrested. Ironically, Victor was charged with possession of a deadly weapon, even though it was the gun he had taken away from May. He avoided being a satisfactory



witness for the prosecution against May and she could not be charged with attempted murder. She received 90 days in jail and he received 15 days in jail and a hefty \$75 fine.

May was in and out of jail for a time, then in August 1916 she was declared insane and sent to an asylum. By 1920, she had returned to Bisbee and continued her rocky relationship with Ritner. On July 19, 1920 a 39-year-old Mamie (May) Gillis finally married the 46-year-old Victor Ritner. The Ritner's resided in Bisbee for the remainder of their lives, passing away in the 1940's

With the Mexican Revolution and a number of casualties on the American side of the Border, American soldiers were stationed at Naco, Arizona. On March 5, 1916, one of district's African-American ladies, Irene Brown ran into trouble with a soldier from the Tenth U.S. Cavalry. In the privacy of her quarters, he robbed her of two dollars by threatening her with a straight razor. Fortunately, he did not get far before he was arrested. A few months later, in September, the Bisbee Daily Review reported a National Guard Unit of Native Americans had returned from a ten-day hike and a pay day. *"For a time it appeared as though the Indians' and others would sack, burn and bury the property in the Gulch."* They did quiet down and the Provost Guard came up from Naco and cleared out any late stragglers. Soldier, John P. Hayes made a poor choice when he robbed an unnamed soiled dove of two watches, a pocketbook and \$14.00. He was arrested and turn over to the Army for discipline.

Florence Sharp was one of the last legal madams of Brewery Gulch. Ornerly and determined, she first ran into trouble in February 1917 when she was caught violating prohibition by having whiskey. She continued to tangle with law enforcement. In late March-April, Florence was arrested for disturbing the peace. After her arrest and fine, she harassed police officers in the district. The officers finally, arrested her for vagrancy and she was fined \$75. Her first arrest for violating Prohibition had little affect and she was charged for alcohol possessions in June 1917. The last mention of her is in early July 1917 when she was fine \$25 for using obscene language.



As the district closed in early December 1917, the women dispersed quickly. Only, two of the ladies from the period of the legal prostitution are recorded to have remained in town. One, who is only known as Hazel Dee became Mrs. Emmett Walsh and lived in Bisbee, until she died in 1969. May Gillis eventually became Mrs. Victor Ritner. In 1940, the Ritner's were living at 205 Van Dyke Street in Warren. At the time, Victor was 65 years-old and Mary was 60. After a lengthy hospital stay, Victor Ritner died on November 25, 1941 and Mary continued to live in Bisbee, but died on May 22, 1943 at the Cochise County Hospital in Douglas, Arizona.

Dens of Dreams

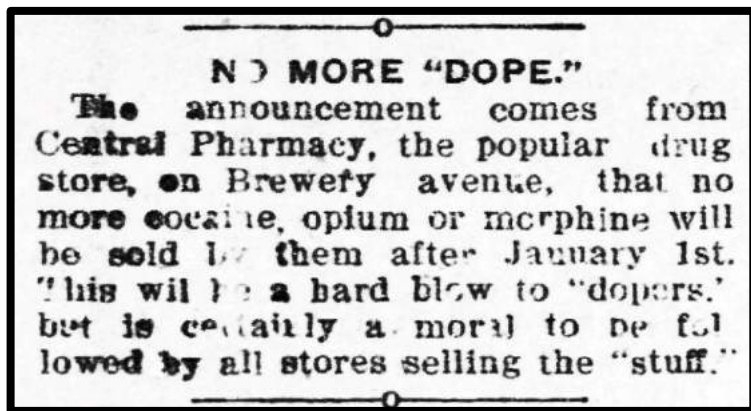

Deeply imbedded in history has been the intimate link between pleasures provided by the female and those provided by substances. Chemical seductresses were also available in the depths of the red-light. Although, opiates were widely available in Bisbee. Generally, these were patent medicines that contained opium and could be purchased at drug stores. These were medical proprietary concoctions of chemicals and often contained significant amounts of alcohol, cocaine and/or opiates. They claimed to cure any variety of human afflictions. In those pre-antibiotic times when diseases were poorly understood, the sick often turned to these for help. They were readily available at drug stores throughout Bisbee. Unfortunately, these patent medicines could be highly addictive and dangerous. Yet, patent medicines did not acquire the strong negative reputation, like smoking opium

Opium is derived from *Papaver somniferum*, better known as the opium poppy. The flower has been grown for centuries to serve ornamental and medicinal needs. Opium poppies produce a white, latex, sap with a disagreeable taste. This sap deters herbivores from eating the plant. Farmers collected the sap by carefully cutting into the



plant's unripened seed pods. The liquid latex was allowed to slowly ooze out and then was scraped off. After, the sap dried it was processed to become smoking opium or in some cases one of medicinal opioids.

In 1909, the police predicted that at least three locations in the red-light district had “*smoking*” opium available. The opium den offered a different experience and was not as simple as drinking from a medicine bottle. Substantial equipment was needed, for opium is not truly smoked, but rather vaporized. The smoker needed to prepare raw opium by “*cooking*.” Also, opium “*smokers*” contrary to modern beliefs preferred company and desired a social environment, not solitude. The distinct lack of a Chinese population in Bisbee allowed the scarlet ladies of the red-light district to fill this niche in the economy of vices.



According to H.H. Kane a late 19th century opium expert, the long pipes were made with a bamboo stem. As the pipe was smoked the yellow bamboo turned a lustrous black and became permeated with opium giving the smoke/vapors and unusual flavor. Bowls were made of hardened clay. The bowls and stems were sometimes instead, made of stacked rings of lemon peel glued together then carved and polished. The lemon provided a pleasant scent to the smoke. Expensive pipes were works of art with silver and ivory decorative fittings.

Components of an opium layout:

*Lamp that burns peanut oil
or sweet oil*

Scissors

Opium box

Tray

A curved bowl cleaner

Straight bowl cleaner

Needle for cooking opium

Tray for hold opium ashes

Sponge for cleaning the bowl

To begin the smoker lit the lamp and “cooked” the opium. They placed a syrupy mass of opium upon the needle and heated it carefully above the burning lamp. Slowly, the color changed from a dark to a golden yellow streaked with black as the opium swelled to six times its original size. The drug was rolled along the bowl and drawn out into thin strings to “cook” the substance thoroughly. After a cooked pea-sized pellet of opium was formed, it was placed into a hole in the bowl of the pipe. The bowl was placed over the lamp, slowly heating the opium. Then the needle was used to pierce the pellet. Then the opium was ready to smoke. A smoker leaned over the



lamp and heated the opium until it began to vaporize. The smoker either breathed in the vapors with either one long draw or several short draws, exhaling through the nose. This process was completed four or five times for a beginner or 100 time an experienced smoker. Opium ashes were saved and ingested or sold to poorer smokers Legend told that women should not smoke an expensive pipe. The moisture from their lips was supposed to cause the pipe to split.

The opium vapors produced nausea, itchness, dizziness then a *“dreamy state of wakefulness”* Sexual desire was increased with a sense of calming peace and contentment. Experienced opium users would introduce young girls to opium with the main intent of seducing them after the opium increased their sexual desires. It was noted that women risquely loosened their corsets and removed their shoes in the company of strangers while in opium dens. During the 1880’s, in San Francisco three ill-famed ladies were challenged to see who could smoke the most opium for a \$50.00 prize The three girls smoked nearly half a pound in 30 hours.

Regardless, opium is a harshly addictive goddess of pleasure and those who seek to cease their relationship with her are doomed to an extended period of torment.

The first recorded arrest for opium use in Bisbee was in 1902 when Charles Ritz was arrested with his complete layout and pipe. The Bisbee Daily Review stated, *“In fact the fumes of the dried poppy penetrated the thick sulphur atmosphere and came floating down the gulch toward the police court... He was dreaming guilty in his cell last night, but couldn’t see a hundred dollars to bail him out.”*

The sulphur fumes is a reference to the smoke from the Copper Queen Smelter which permeated the early community. His arrest was followed the next year by the arrest of red-light madam, Cora Miles and Joel Gibson. Naco, Sonora was thought to be source of opium and this was at least partially true. In 1906, eighteen people including several Bisbee residents and a woman were arrested after being discovered smoking opium in Naco, Sonora. Even women were

Suspected of smuggling opium from Naco into Bisbee. After C.E. Biddenger and B.A. Lacey were arrested for possession of cocaine and pipe opium, they claimed to have purchased the drugs in Warren. The police interrogated an important Warren resident who responded. *“Sure Mike,” “Why I’m one of the stockholders. What are you going to do about it?”* The source of the opium was never positively determined to be from Warren, although the police searched the area intensely. The two men told the arresting officers, how they learned to smoke opium in the Chinatown at San Francisco.

During 1908, a letter published in the Bisbee Daily Review brought opium dens temporarily to the forefront of concern.

“Bisbee, Ariz, June 2, 1908

Mr. John Stevens,

City Marshall”

“I will try to see if you will enforce this letter. It is in regard to a negro opium joint which my son frequents day and night with women of the red light district. I have went after him several times and he always comes home sick and broke and unless it is broke up soon we can’t have money to buy bread. He says he spends his wages and can’t keep from it, so you do me and my little girl a favor by breaking it up at once. The location is up Brewery Gulch on the left hand side in the back of the colored prostitute house in a building that’s an old hack stand. Under there is several negro men and three or four white girls every morning between 3 and 4 o’clock.

The den was raided, but since smoking opium was not illegal, the men including Walter Dean and Merrill Gilland were charged only with vagrancy. During the arrests an unusually beautiful and well used opium pipe was seized. The stem was bamboo decorated with silver and ivory.



In the following years, a few arrests were made and layouts and pipes were seized along with any opium. In 1911, Pete Cook was arrested for having a “*Snow Party*,” (cocaine) but the police noted that the room was arranged like an opium den with mats on the floors and chairs against the walls. While investigating the theft of \$600.00 worth of jewelry from ill-famed lady, Mamie Williams they located an opium layout in the possession of Abe Fields a man who followed carnivals. The layout included a beautiful pipe of fine workmanship and opium ashes.

Opium arrest quieted down until 1916, when officers noticed two men and two women enter a building on Naco Road owned by “*Monte Jack*” a frequent guest of justice courts. Upon entering the property officers discovered opium, needles and a cooking lamp, but no pipes. Fannie Evans, Tom Evans, Will Martin and Edith Darnell were charged with smuggling opium. Tom Evans is believed to have owned the opium layout. He was later sentenced to one year in prison. Fannie his wife was released. The last noted arrest of smoking opium was in 1916, when police arrested Dollie St. Clair and George Warren at the Ozark House. Originally, the officers could not find a smoking layout, but during a second search they discovered the pipes, layout, lamps, opium ashes, opium, morphine and powder cocaine, “*Snow*”.

Opium dens did exist in Bisbee. At any given time there were a small number of dens in the red-light district, but in comparison to the number of arrests for drunken brawls the problems caused by smoking opium were small. Although, it may have been devastating to an individual or family, the community was faced with more serious issues, such as typhoid.

Women Enslaved

Near the U.S. Mexican border, Bisbee's location made the white slavery issue more prominent than communities in the interior of the United States. In the late 19th and early 20th centuries, a "*White Slave*" was defined as a woman who has been brought into the immoral life of the red-light. Laws were passed to theoretically protect women from being forced into prostitution by the numerous proprietors and madams of ill-famed houses and those that procured women for them. The original purpose of these laws were built on good intention and then were corrupted with enforcement and liberal interpretations of the laws. Women of the red-light were pitied, but still given a level of dignity and respect. This was a sharp contrast to procurers and pimps who were held in vile and contempt. Where a prostitute could be considered a victim of social conditions. Procurers and pimps were committing a grave social crime by greedily profiting from the sins of others and at times against their will. The community found little mercy for these individuals.

There is little doubt women and girls were forced into the ill-famed life in Bisbee. Felix Taylor, was the only man prosecuted in the community for this action. The circumstances which may drive a woman to prostitution were common. Poverty dominated sections of the community, like Tintown and Zacatecas Canyon. Employment opportunities for an unmarried woman, widow or wife of a cripple was extremely limited. Bisbee was home to a significant number of young widows. Nationwide women of this nature were prey for men and women seeking to induce them into the red-light lifestyle. Over 200 men were killed in the mines alone, during the red-light district's years of operation. A larger number were crippled. This number does not include men killed at the smelters or the railroad. Both of these industries were also notoriously dangerous. Although, it was diseases



that killed and crippled the majority of men. Youthful innocence, the allure of excitement and independence were other draws to the red-light life style. Arthur McKerrarcher, Mrs. Andy Miller and Mrs. Kathryn Mabry found themselves at odds with law enforcement, by using these enticements to lure young girls.

Before 1910, when the “White Slave Traffic Act” also known as the Mann Act was passed, laws already stated that any immigrant woman who turned to the ill-famed lifestyle before she had lived in the United States three years could be deported. Arrests were made and women were deported.

This happened to Lily Silver, a French girl of extraordinary beauty. She had first entered the United States in 1908 along with two other French girls and two Frenchmen. Although, she was promised a high-paying position as a waitress, as soon as she arrived Lily began work as an ill-famed lady. She was arrested and deported back to France. Lily returned to the United States and speaking little English continued the ill-fame lifestyle. This time, she was arrested in Bisbee and was going to be deported again. Albert Telley, a young man from Bisbee offered to marry her to prevent the deportation. Lily Silver was not the only young woman who was promised high paying employment only to learn it involved working in a red-light district. In 1906, the Sherwood sisters were contracted in Chicago to come to Bisbee and work at the People’s Theatre for \$70.00 a week. When they arrived, the girls discovered that the theatre was located in the heart of Bisbee’s red-light district. Fortunately, they sought the advice of a lawyer who explained they could not be forced to work in the district.

It was not until 1909 that “*white slavery*” was drawn to the forefront. Charles T. Connell was assigned as an immigration inspector for the Southwest. Mr. Connell spent time investigating ill-famed houses from El Paso thru New Mexico to Phoenix. Bisbee was part of his territory. He spent his investigations focused on international smuggling of girls. The inspector had a reason to be



interested in Bisbee. August Contreras had been arrested for importing Mexican women to work at the Little Club in 1904. Frenchman, Emile Lefebvre proprietor of the Canadian Club and his “wife” Marguerite Lefebvre quickly attracted Connell’s interest. Connell sent a letter to the immigration inspector in San Francisco requesting information on the couple who were believed to have operated the Cozy Corner Saloon and a dance hall in Goldfield, Nevada.

Abraham A. Rosenwald was the next Bisbee resident that interested Connell. Unfortunately, Rosenwald was arrested in Bisbee on a vagrancy charge and Rosenwald, Sadie Kline and Ida Rosenwald left Bisbee, before Connell could gather enough information to charge Rosenwald with importing ill-famed women.

In 1910, after, Connell investigated Bisbee’s red-light district, the Mann Act was passed. This legislation made it illegal to transport women across state or international borders for an “immoral purpose.” The government was left to define immoral.

Problems developed with the “white slavery” law with cases like, the arrest of Mexican Revolutionary General Ignacio L. Pesquiera. He had been waiting in the United States, until he was ordered to return to Mexico to become Military Governor of Sonora for Carranza’s army. The 65-year-old man had traveled with Senora Maria Rodriguez, a 23 year-old married woman. Even though their relationship was consensual, General Pesquiera was arrested. They were held on a white slavery charge at Douglas, Arizona for 10 hours until a \$1000.00 bond was raised. This incident made it clear that the law was going to be used to arrest men traveling with women for an immoral purposes, even though the women were not prostitutes and any sexual relations were consensual and non-commercial.. Through a *Caminetti vs the United States* the U.S. Supreme court upheld the law’s use in this manner. The law was also interpreted to mean that it was illegal to pay for any transportation of ill-famed ladies. The Bisbee Daily Review stated the law was written, so vaguely that if a man gave a red-light girl a nickel to take the street car from Lowell to



Bisbee, he had committed “*white slavery.*” Pauline Wells was arrested in Douglas, Arizona in 1911, for paying for the railroad fare of two ill-famed ladies from Tucson to Bisbee. A few months later, Harry Miller a resident of Bisbee was charged with white slavery after purchasing a railroad ticket for a lady from El Paso to Bisbee. He disappeared forfeiting a \$2,500.00 bond. If the intent of the law was to prevent the importation of large numbers of immoral women then it failed. White slavery arrests continued to be made, but normally centered around individual girls not large numbers of women being imported. During 1913, Augustine Daley was arrested after he sent money to Lugarda Ensinas to travel from Nogales to Bisbee.

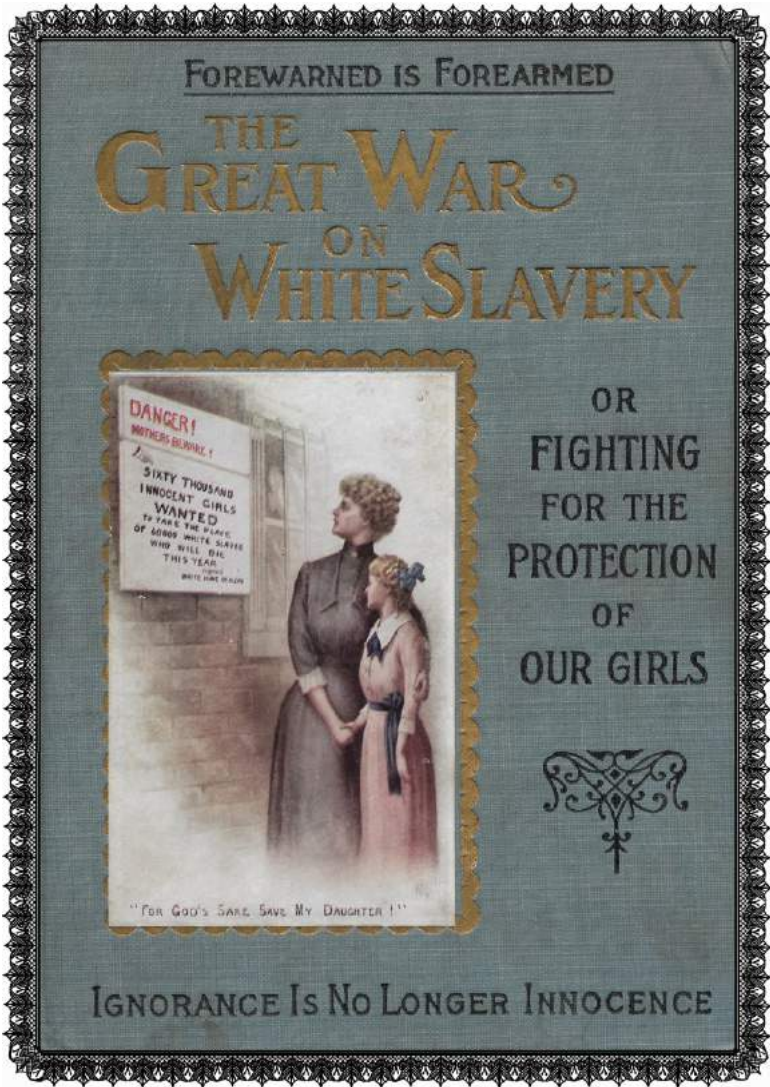


A street car heading from Lowell to Bisbee c-1910

In early 1914, the U.S. Federal Government wanted to capture Felisalio Simons. He was wanted for white slavery, kidnapping and suspected of murder. Simons had kidnapped three men in Baja, Mexico including his consort’s Amelia Sanpey’s father. A few feet from the U.S border Amelia’s father was murdered. Unknowing that Simons had killed her father Amelia travel to Los Angeles and then to Bisbee. At Bisbee, she took up residence in the red-light district for one month. After which enticed by the lure of Mexican silver she



moved to Aqua Prieta, Sonora Mexico. In order to catch Simon, the law enforcement officers which included Bisbee City Marshall,

Bassett Watkins and Officer Walter Brooks, U.S. Marshall James McDonald and Secret Service agent Breinniman had a Mexican man offer Amelia money to come to a “*disreputable roadhouse*” in Pirtleville, Arizona. (near Douglas) The officers suspected that Simon would follow Amelia across the border to take the money from her. Knowing that the roadhouse would be filled with friends of Simon, the officers wanting to avoid bloodshed, they pulled up to a side door of the building. They entered the room and arrested Simon, Amelia and another man before anyone knew what was happening. Simon and Amelia were transported to Bisbee and the undescribed man was released. During the road trip to Bisbee, Simon made it clear he had not intended to be taken alive.

Each following years, a few arrests were made most of these small cases involving a man and a woman traveling together, but were not married. Miner, Joseph Griffith went to England and met a Cornishwoman, Susan Ferrell in 1915 and promised to marry her. She sailed from England to Ellis Island and was allowed entry to the U.S. due to her planned marriage with Griffith. The marriage was expected to occur on her arriving in Bisbee in November. By February 1916, they still not married and Ferrell filed a charge of white slavery against Griffith. A promise of marriage was often used to lure young women into a life of prostitution.

In 1922, an interesting case appeared. Two men were charged with white slavery for transporting two girls into Mexico for immoral purposes. Seventeen year-old Opal Humpherys and 19 year-old Lillie Saathoff, both Bisbee girls went to Nogales, Sonora Mexico to work in the cabarets. The girls were immediately arrested when they crossed the Mexican border into Nogales, Arizona. William Stanton and Fred Davis the men were arrested on this white slavery charge.

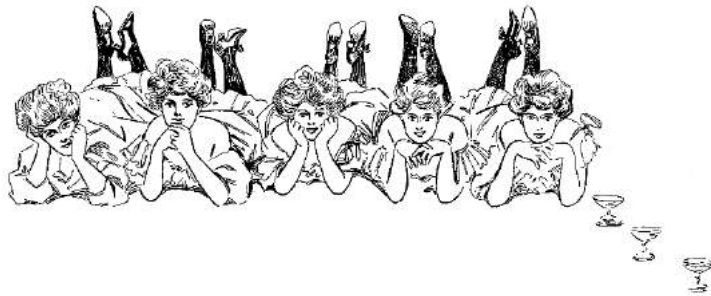
The white slavery issues appears to actually have been much smaller in reality than in fiction. Movies, books and vaudeville plays had inspired the public to see white slavery as a bigger problem than it actually was. The investigations of Immigration Inspector C.T.



Connell reveal that in at least the in the Southwest the far majority of ill-famed ladies were American born. In 1916, the Bisbee Daily Review reported that the law had resulted in more harm than good. Since the law had been applied to all women, not only prostitutes a large number of black mail issues had arisen. The Review felt the law should be repealed and *“It has made the Federal Government a meddler in private affairs and a silent partner to blackmailers.”*

Yet, the anti-white slavery movement, a crusade strongly pushed by Christian religious groups, developed enlightened solutions that were controversial for the time. These ideas blended well with the women’s suffrage movement. Arguably, the most significant was the idea that women should be paid a fair wage that enabled them to adequately support themselves. A more radical suggestion was the idea that all children should be taught sex education. Children should be educated in heterogeneous groups and be taught age appropriate lessons about sex in three formats, parental, religious and scientific. The subject would start with ten-year-olds and continued until the end of schooling. Reaching into biblical stories the anti-white slavery movement focused on references to the Prodigal Son and Mary Magdalene. The member of movement argued that a *“prodigal son”*, son who had left his early 20th century family to live a wayward and sin filled life could return home and be forgiven and accepted with open arms. Yet, a *“prodigal daughter”* was sneaked into the home, thru the backdoor and was forever tarnished. The movement sought to remove the double standard of morality based on gender and provide *“Christian forgiveness”* to ladies of the red-light. Conditions for women were moving forward.

Banta, Maggie: She was accused for living at a red-light house and not paying her room rent. Her case was presented by lawyers and the testimony given by other soiled doves did not end until 10:00 pm. A verdict of not guilty was presented at midnight. Beach, Miss: She worked in the district in 1901 and likely at or near the Hog Ranch. "Cochise County Coroner's Inquest #4" Arizona State Archives Phoenix



Beaumont, Ada: This lady was seriously if not mortally injured while riding a rented horse along Naco road. The newspaper reported that she was refined and had come from a fine family in Lexington, Kentucky. Her fellow ill-famed ladies help her pack her belongs to return home to likely die and removed anything that would indicate her illicit past to her mother. The Copper Queen Hospital records contradict at least partially the newspaper's story. It indicates she had lived in Bisbee for 14 of her 25 years and that her mother was deceased. Her father, Alfred B. Grubb was living in Spears, Kentucky. Mrs. J.G. Jones of 706E Main St. Lexington, Kentucky was her sister and she had an uncle, Will Holman of Athens Georgia. She was released from the hospital August 18, 1907 in improved condition. A year earlier, she accused Otto Henkel of stealing a saddle and bridle.

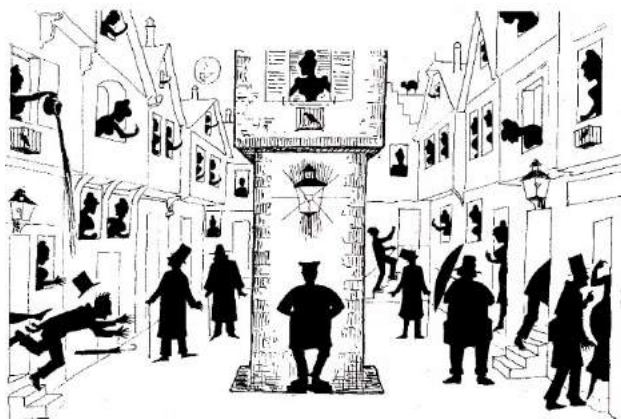

Baptista struck one man with a chair and seized his knife and the other man ceased fighting. Later, he was a member of jury that found Mrs. Thomas Fox guilty of practicing her profession outside the limits of the red-light district. In late 1905, Baptista offered to donate a \$6,000 section of property to the city to build a school. This school would have forced the red-light district to move further up Brewery Gulch. The suggested school was not built, but the red-light district was moved a 100 feet up the gulch after the completion of the new Central School building. This became problematic for Baptista as the new boundary left one of his buildings half in and half out of red-light district. Baptista asked for the city to consider the building as part of the red-light district, but the community declined. It is likely, that Grace White and Jessie Feilstan were arrested while working from this building.

Constables, Wilmoth and White later raided the Norton House which was suspected to be operating as a house of ill-repute, outside the designated district. 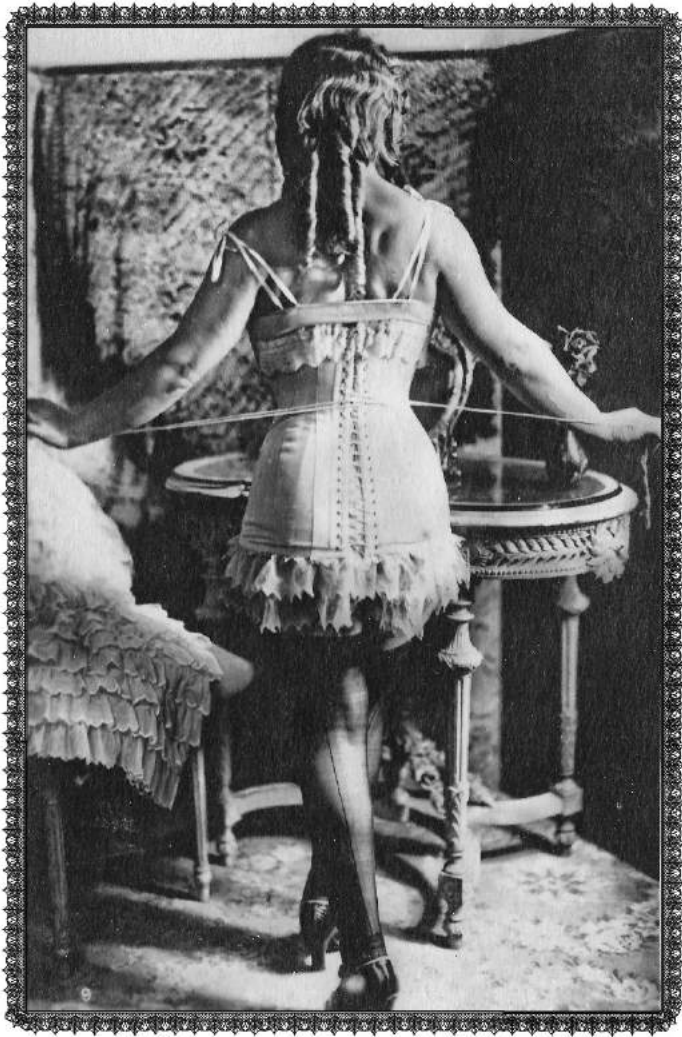
